# FRIDAY, 4 SEPTEMBER 1970

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Bennett presented a petition from certain citizens of Western Australia praying that the House consider the hardship caused to home buyers in that State by the increased interest rates on mortgage contracts which result from the recent increase in the interest rate on Government bonds.
  - Mr Fox presented a petition from certain residents of New South Wales praying that the export of all kangaroo products be banned immediately.

Petitions severally received and read.

- A similar petition to that presented by Mr Fox was presented by Mr Wentworth (Minister for Social Services), and was received.
- Mr Reid presented a petition from certain residents of Victoria praying that the export of products made from kangaroos be banned and the Commonwealth Government take necessary steps to have all wildlife in Australia brought under its control.

Petition received.

- Mr Foster presented a petition from certain citizens of the Commonwealth praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.
- Mr Keogh presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.

Petitions severally received and read.

- A similar petition to that presented by Mr Keogh was presented by Mr Garrick, and was received.
- Mr Reynolds presented a petition from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
- Mr Kennedy presented a petition from certain electors of the Division of Bendigo praying that the House seek to ensure that Commonwealth legislation bearing on censorship of films, literature and radio and television programmes is so framed and so administered as to preserve sound moral standards in the community.

Petitions severally received and read.

A similar petition to that presented by Mr Kennedy was presented by Mr Lynch (Minister for Immigration), from certain electors of the Division of Flinders, and was received.
