- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Gun presented a petition from certain citizens of the Commonwealth praying that the House make legal provision for a further undergraduate representative on the Council of the Australian National University.

Petition received.

- Mr L. R. Johnson presented a petition from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
- Mr Davies presented a petition from certain citizens of the Division of Braddon praying that the House seek to ensure that Commonwealth legislation bearing on films, literature and radio and television programmes is so framed and so administered as to give the maximum freedom to adults to choose what they will watch, read and listen to, even in the face of pressure from those who seek to impose their ideas and morals on others who do not share them.

7 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—PRICES AND TRADE PRACTICES ACT: Mr Speaker informed the House that Mr Patterson had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Government to protect the Australian consumer and export industries from rapidly increasing prices and to apply and extend the Trade Practices Act".

8 PAPUA AND NEW GUINEA LOAN (INTERNATIONAL BANK) BILL 1970: Mr Lynch (Minister assisting the Treasurer), pursuant to notice, presented a Bill for an Act to approve the Guarantee by the Commonwealth of the Discharge of the Obligations of the Administration of the Territory of Papua and New Guinea under a Loan Agreement made with the International Bank for Reconstruction and Development, and for purposes connected therewith.

Bill read a first time.

Mr Lynch moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

9 CUSTOMS TARIFF PROPOSALS No. 21 (1970): Mr Chipp (Minister for Customs and Excise) moved Customs Tariff Proposals No. 21 (1970).

Debate adjourned (Mr Patterson), and the resumption of the debate made an order of the day for the next sitting.

15 COMMONWEALTH PLACES (APPLICATION OF LAWS) BILL 1970: Mr Hughes (Attorney-General), by leave, presented a Bill for an Act relating to the Application and Administration of Laws in Places acquired by the Commonwealth for Public Purposes.
Bill read a first time.

Mr Hughes moved—That the Bill be now read a second time.

Debate adjourned (Mr Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

16 BANKRUPTCY BILL 1970: Mr Hughes (Attorney-General), by leave, presented a Bill for an Act relating to Bankruptcy.
