THURSDAY, 29 OCTOBER 1970

- 1 The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr J. F. Cairns presented a petition from certain citizens of Melbourne praying that Australia increase financial aid to less wealthy underdeveloped countries and revise trade and tariff policies and practices in order to make available, both in Australia and overseas, more markets for goods from less developed countries.
 - Mr Kirwan presented a petition from certain citizens of Australia praying that the House give earnest consideration to the crisis in Aboriginal welfare which exists in the South West Land Division of Western Australia.

Petitions severally received and read.

Similar petitions to that presented by Mr Kirwan were presented by Mr Beazley, Mr Collard, Mr Webb and Mr Bennett, and were severally received.

Mr Hurford presented a petition from certain citizens of South Australia praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.

Petition received and read.

Similar petitions to that presented by Mr Hurford were presented by Mr C. R. Cameron and Mr Gun, by Mr L. R. Johnson, from certain citizens of New South Wales, and by Mr L. K. Johnson, from certain citizens of Victoria, and were severally received.

- Mr Bennett presented a petition from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which lead to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention of and rehabilitation of criminals and (4) compensation to victims of crimes of violence.
- Mr Klugman presented a petition from certain citizens of New South Wales praying that the House seek to ensure that Commonwealth legislation bearing on films, literature and radio and television programmes is so framed and so administered as to give the maximum freedom to adults to choose what they will watch, read and listen to, even in the face of pressure from those who seek to impose their ideas and morals on others who do not share them.

Petitions severally received and read.

- A similar petition to that presented by Mr Klugman was presented by Mr Turner, from certain citizens of the Division of Bradfield, and was received.
- Mr L. K. Johnson presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.

Mr Cohen presented a petition from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Petitions severally received and read.

A similar petition to that presented by Mr Cohen was presented by Mr Klugman, and was received.

Mr Bryant presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) Aboriginal ownership of existing reserves throughout the Commonwealth, (2) the recognition of Aboriginal ownership of traditional land at present owned and leased by the Crown and (3) the development of mining, pastoral and other enterprises on all Aboriginal land to be subject to the consent of Aboriginal owners and such conditions as their own legal advisers may arrange.

Petition received and read.

5 AIRCRAFT NOISE—SELECT COMMITTEE—REPORT—STATEMENTS BY MEMBERS: Mr Buchanan (Chairman) brought up the Report from the Select Committee on Aircraft Noise, together with the Minutes of Proceedings of the Committee.

Ordered—That the report be printed.

Mr Buchanan, Mr Jones, Mr Robinson, Mr L. F. Bowen, Mr L. H. Irwin, Mr Morrison and Mr Swartz (Minister representing the Minister for Civil Aviation), by leave, made statements with reference to the report.

6 DEVELOPMENT OF AVALON AIRPORT TO BOEING 747/CONCORDE STANDARD—APPROVAL OF WORK: Mr Chipp (Minister representing the Minister for Works) moved, pursuant to notice—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the committee has duly reported to Parliament: Development of Avalon Airport to Boeing 747/Concorde standard.

Mr Jones moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: ", because insufficient foresight has been exercised in planning Australia's present and future commercial jet pilot training facilities so as to avoid adverse effects from aircraft noise on established and expanding communities and immediate steps should be taken to plan and construct elsewhere a facility for commercial jet pilot training, the development of Avalon Airport be referred back to the Public Works Committee".

Debate continued.

Mr Reynolds rising to address the House-
