- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Jenkins presented a petition from certain citizens of Victoria praying that this House take immediate steps to increase the base pension rate to 30 per cent of average weekly male earnings.

Petition received and read.

A similar petition was presented by Mr Cass, and was received.

Petitions from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children were presented by Mr Turner and Mr Uren.

Petitions severally received.

Mr Reid presented a petition from certain residents of Cranbourne and surrounding district praying that the export of products made from kangaroos be banned and that legislation be passed to make the kangaroo a protected animal throughout Australia.

Mr Fox presented a petition from certain citizens of the Commonwealth praying that the Australian delegation to the United Nations be directed to question the Brazilian delegation regarding the social freedom of their countrymen.

Petitions severally received and read.

- 3 Questions: Questions without notice were asked.
- 4 STANDING ORDERS COMMITTEE—REPORT DATED 15 FEBRUARY 1971: Mr Speaker (Chairman) brought up from the Standing Orders Committee a report, dated 15 February 1971, relating to the quorum of Members of the House of Representatives.

- 5 Immigration (Education) Bill 1970: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Daly, viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not refusing to give the Bill a second reading, this House condemns the Government for the delay in providing a comprehensive programme of migrant education, adequate finance facilities and capital equipment, including buildings"—

Debate resumed.

Question—That the words proposed to be omitted stand part of the question—put.

On the motion of Mr Lynch (Minister for Immigration), the following amendment was made, after debate: Clause 2, page 1, lines 5 and 6, omit "first day of July, One thousand nine hundred and seventy", insert "day on which it receives the Royal Assent".

Bill, as amended, debated and agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Lynch, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

6 MAPPING SURVEYS BILL 1970: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Wentworth (Minister for Social Services), the Bill was read a third time.

7 ADJOURNMENT: Mr Hunt (Minister for the Interior) moved—That the House do now adjourn.

Debate ensued.

Question—put and passed.

And then the House, at twenty-six minutes past ten o'clock p.m., adjourned until tomorrow at half-past ten o'clock a.m.
