TUESDAY, 9 MARCH 1971

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Suspension of standing orders—Statements by Members: Mr Whitlam (Leader of the Opposition) moved—That so much of the standing orders be suspended as would prevent statements being made forthwith by the honourable Member for Wannon (Mr J. M. Fraser) and the Prime Minister (Mr Gorton).

Debate ensued.

Question-put and passed, with the concurrence of an absolute majority.

3 THE HONOURABLE MEMBER FOR WANNON (MR J. M. FRASER)—RESIGNATION FROM MINISTRY—STATEMENTS BY MEMBERS: Mr J. M. Fraser made a statement with respect to his resignation from the portfolio of Minister for Defence.

Mr Gorton (Prime Minister) also made a statement in connection with the matter.

4 Suspension of standing orders moved—Motion without notice: Mr Whitlam (Leader of the Opposition) moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving that Mr Alan Ramsey, who misconducted himself in the Press Gallery of the House, be brought before the Bar of the House when the House meets tomorrow.

Debate ensued.

Motion withdrawn, by leave.

- 5 Petitions: Mr Martin presented a petition from certain citizens of Australia praying that the House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.
 - Mr Klugman presented a petition from certain citizens of Australia praying that the House seek to ensure that Commonwealth legislation bearing on films, literature and radio and television programmes is so framed and so administered as to give the maximum freedom to adults to choose what they will watch, read and listen to, even in the face of pressure from those who seek to impose their ideas and morals on others who do not share them.
 - Mr FitzPatrick presented a petition from certain citizens of New South Wales praying that, in respect of taxation concessions, the Government will take immediate steps to (1) investigate the location of Zone A and Zone B areas so that towns of equal isolation and cost factor will receive the same Zone concession, (2) investigate with a view to increasing the amount of concession entitlement for Zone B and (3) amend the Income Tax Assessment Act so that travel and accommodation expenses be allowable deductions when there is a requirement to travel from isolated areas to cities for specialist medical treatment.

Petitions severally received and read.

6 MINISTERIAL CHANGE AND ARRANGEMENTS: Mr Gorton (Prime Minister) informed the House that on 8 March Mr J. M. Fraser had resigned as Minister for Defence and that, for the time being, Sir Alan Hulme (Postmaster-General) would answer questions with respect to the Defence portfolio and represent the Minister for Supply (Senator Sir Kenneth Anderson) in the House.

- 7 QUESTIONS: Questions without notice were asked.
- 8 Message from the Senate: A message from the Senate was reported returning the following Bill without amendment:
 - 25 February 1971—Message No. 127—Australian National University 1971.
- 9 Message from the Governor-General—Assent to Bill: A message from His Excellency the Governor-General was announced informing the House that His Excellency, in the name of Her Majesty, had assented to the following Bill:
 - 2 March 1971—Message No. 93—Australian National University 1971.
- 10 New South Wales Grant (Flood Mitigation) Bill 1971: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Patterson who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "whilst welcoming the proposal for the purpose of flood mitigation works in New South Wales, this House is of opinion that the assistance offered is inadequate and should form part of a larger scheme to deal with national disaster and that, accordingly, a joint select committee of the Parliament should be appointed to inquire into the practicability of the establishment of a national disaster organisation".

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put. The House divided (the Deputy Speaker, Mr Lucock, in the Chair)—

Ouestion—put and negatived.

Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr Drury reported accordingly.

On the motion of Mr Swartz (Minister for National Development), the House adopted the report, and, by leave, the Bill was read a third time.

- 11 APOLOGY BY PRESS REPRESENTATIVE—STATEMENT BY MR SPEAKER: Mr Speaker informed the House that he had received a letter from Mr A. Ramsey apologising unreservedly for his conduct in the Press Gallery this afternoon and expressing his deep and sincere regrets.
- 12 ADJOURNMENT: Mr Swartz (Minister for National Development) moved—That the House do now adjourn.

Question-put and passed.
