TUESDAY, 7 SEPTEMBER 1971

- 1 The House met, at half-past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PRIVILEGE—ARTICLE IN THE "DAILY TELEGRAPH"—REFERENCE TO COMMITTEE OF PRIVI-LEGES: Mr Cope raised a matter of privilege based upon an article published in the *Daily Telegraph* on Friday, 27 August 1971 under the heading "COUNT OUT' SHUTS PARLT.". Mr Cope produced a copy of the *Daily Telegraph* containing the article and gave the names of the printer and the publisher of that newspaper.

Mr Cope then moved—That the matter of the article in the *Daily Telegraph* of Friday, 27 August 1971 be referred to the Committee of Privileges.

Debate ensued.

Question-put and passed.

3 PETITIONS: Mr Whitlam (Leader of the Opposition) presented a petition from certain citizens of Australia praying that the House take immediate steps to abolish the means test for all people who have reached retiring age or who otherwise qualify for social service benefits or pensions.

Petition received and read.

- Mr Foster presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses, (4) an increase in the maintenance allowance for students and (5) the exemption of non-bonded scholarships for part-time students from income tax.
- Mr L. H. Irwin presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.

Petitions severally received.

- Mr Klugman presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
- Mr Morrison presented a petition from certain citizens of Australia praying that this House should cause the Australian Government to recognise the right of Australian professional people engaged in the creative and performing arts to further develop their skills and talents in Australia, and to be protected from overseas programmes in a way that will encourage an Australian television and radio industry.

- Mr Uren presented a petition from certain citizens of Australia praying that the Government increase immediately pensions by \$5.00 per week, child endowment to \$3.60 per week per child and the maternity allowance to at least \$117.00 for each child born. Petitions severally received and read.
- Mr Birrell presented a petition from certain citizens of the Australian Capital Territory praying that the words: "or for preventing conception" be deleted from sub-section (1.) of section 46 of the A.C.T. Pharmacy Ordinance. Petition received.

- 11 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—CORPORATIONS POWER OF THE COMMON-WEALTH: Mr Speaker informed the House that Mr Whitlam (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The need to pass laws relating to trade practices, consumer protection, consumer credit, securities markets and overseas control under the Commonwealth's corporations power".

The proposed discussion having received the necessary support-

Mr Whitlam addressed the House.

Ordered-That Mr Whitlam be granted an extension of time.

Discussion ensued.

Ordered-That Mr Hughes be granted an extension of time.

Discussion continued.

Discussion concluded.

12 BROADCASTING AND TELEVISION BILL (No. 2) 1971: Sir Alan Hulme (Postmaster-General), pursuant to notice, presented a Bill for an Act relating to Licences for Broadcast and Television Receivers.

Bill read a first time.

Sir Alan Hulme moved—That the Bill be now read a second time.

Debate adjourned (Mr Crean), and the resumption of the debate made an order of the day for the next sitting.

- 13 RESUMPTION OF LAPSED BUSINESS—APPROPRIATION BILL (No. 1) 1971-72—BUDGET DEBATE: Mr Swartz (Leader of the House) moved, by leave—That the proceedings on the Appropriation Bill (No. 1) 1971-72, which lapsed on Thursday, 26 August 1971, be resumed forthwith at the point where they were interrupted. Question—put and passed.
- 14 APPROPRIATION BILL (No. 1) 1971-72—BUDGET DEBATE: Debate resumed on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Whitlam (Leader of the Opposition), viz.—That all words after "That" be omitted with a view to inserting the following words in place thereof: "the House condemns the Budget because (a) it breaks the Prime Minister's pledge to Parliament on taking office to bring into effect for 1971-72 a fundamental review of social services and of methods for adjusting them, (b) it contains no proposals to balance the finances and functions of the Commonwealth, the States and local government and (c) it produces no programmes for high national objectives of social welfare, economic strength and national security".

Ordered—That Mr McMahon (Prime Minister) be granted an extension of time. Debate continued.

Suspension of sitting: At fourteen minutes past nine o'clock p.m., the Deputy Speaker (Mr Drury) vacated the Chair until the ringing of the bells.

Resumption of sitting: At twenty-two minutes past nine o'clock p.m., Mr Deputy Speaker resumed the Chair.

Debate continued.

Debate adjourned (Mr Kennedy), and the resumption of the debate made an order of the day for the next sitting.

15 ADJOURNMENT: Mr Mackay (Minister for the Navy) moved—That the House do now adjourn.

Question-put and passed.

And then the House, at six minutes to eleven o'clock p.m., adjourned until tomorrow at half-past two o'clock p.m.
