TUESDAY, 2 NOVEMBER 1971

- 1 The House met, at three o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Reid presented a petition from certain citizens of Australia praying that the Government grant income tax deduction for donations over \$2 made towards the relief of overseas disaster areas and that this be effected with haste to ensure the maximum possible aid to those at present in refugee camps and those in danger of famine in East Pakistan.
 - Mr Calder, Mr Reid and Mr J. F. Cairns each presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan, and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.
 - Mr Cass and Mr L. K. Johnson each presented a petition from certain citizens of Australia praying that this House (1) increase monetary aid for the Pakistani refugees to at least \$10 million immediately, (2) encourage and sponsor teams of volunteers with needed skills and medical supplies and (3) maintain this aid for as long as the crisis persists.
 - Mr J. F. Cairns also presented a petition from certain citizens of Australia praying that the Government take steps to offer employment, at least on a temporary basis, in order to effect some relief, to academic and qualified persons among the refugees from Bangla Desh.
 - Mr Pettitt presented a petition from certain citizens of Australia praying that the Government go beyond the plea of the Prime Minister for magnanimity and compassion in the trial of Sheikh Mujibur Rahman on charges of treason and insist on the liberty of this openly and democratically elected leader.

Petitions severally received.

Mr Klugman presented a petition from certain citizens of Australia praying that this House seek to have Australia adopt the principle followed by Britain, Italy, Greece, Malta, The Netherlands, France, Germany, Turkey, Canada and the United States of America, which already transfer the social entitlement of their citizens wherever they may choose to live.

Petition received and read.

- Mr Armitage presented a petition from certain citizens of the Commonwealth praying that this House make legal provision for (1) the allowance of personal education expenses as a taxation deduction, (2) the removal of the present age limit in respect of the deduction for education expenses, (3) an increase in the deduction allowable for tertiary education expenses, (4) an increase in the maintenance allowance for students and (5) the exemption of non-bonded scholarships for part-time students from income tax.
- Mr L. F. Bowen presented a petition from certain citizens of Australia praying that this House should (1) increase monetary aid for the refugees in India to at least \$10 million immediately and make provision for a further and extra grant for the victims of the famine in East Pakistan, (2) grant tax deductibility to donations of \$2 and over to Australian voluntary agencies working with the refugee problem and (3) ensure that the Australian Government does all in its power to help bring about a political settlement which would be acceptable to the people of East Pakistan.

- Mr Cass also presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
- Mr L. K. Johnson also presented a petition from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Mr Giles presented a petition from certain electors of the Division of Angas praying that section twenty-six of the National Service Act be repealed.

Petitions severally received.

Mr Klugman also presented a petition from certain citizens of the Commonwealth praying that the House seek to ensure that Commonwealth legislation bearing on films, literature and radio and television programmes is so framed and so administered as to give the maximum freedom to adults to choose what they will watch, read and listen to, even in the face of pressure from those who seek to impose their ideas and morals on others who do not share them.

Petition received and read.

Mr Katter presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.

Petition received.

- 3 MINISTERIAL ARRANGEMENTS: Mr Anthony (Acting Prime Minister) informed the House that, during the respective absences abroad of Mr Sinclair (Minister for Primary Industry) and Mr N. H. Bowen (Minister for Foreign Affairs), Mr Nixon (Minister for Shipping and Transport) was acting as Minister for Primary Industry and Mr Swartz (Minister for National Development) was acting as Minister for Foreign Affairs.
- 4 QUESTIONS: Questions without notice were asked.
- 5 Papers: The following papers were presented, pursuant to statute:

- 6 Leave of absence to Member: Mr Whitlam (Leader of the Opposition) moved—That leave of absence for one month be given to the honourable Member for Blaxland (Mr Keating) owing to his absence from Australia.

- 7 Public Works Committee—Report: Mr Kelly (Chairman) brought up the following report from the Parliamentary Standing Committee on Public Works:

and, by leave, made a statement in connection with the report.

Ordered—That the report be printed.

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—SOUTH HEAD ENVIRONMENT AND HARBOUR NATIONAL PARK, SYDNEY: Mr Speaker informed the House that Mr L. R. Johnson had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The Government's failure to co-operate with the Government of New South Wales in preserving the environment of South Head and in establishing a Sydney Harbour National Park".

The proposed discussion having received the necessary support—

Mr Johnson addressed the House.

Discussion ensued.

Ordered—That Mr Mackay (Minister for the Navy) be granted an extension of time. Discussion continued.

Discussion concluded.

10 INCOME TAX BILL 1971: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Crean who moved, as an amendment—That all words after "That" be omitted with a view to inserting the following words in place thereof: "the Bill be withdrawn and re-drafted because it (a) does not comprehensively restructure the rate schedule and (b) increases the tax payable by certain individuals on a flat percentage basis".

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put.
