- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: Mr Garrick presented a petition from certain citizens of Australia praying that the Government will provide \$10 million for relief purposes in India and East Pakistan, and a further \$50 million over 3 years to help rehabilitate the refugees in East Pakistan.
 - Mr Bennett and Mr Casseach presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.
 - Mr Maisey and Mr Berinson each presented a petition from certain electors of Australia praying that the Government revise its interpretation of the Geneva Protocol of 1925 relating to chemical agents of warfare, and declare that it regards all chemical substances employed for their toxic effects on man, animals or plants, as being included in the prohibitions laid down by that Protocol.
 - Mr Bennett also presented a petition from certain citizens of Australia praying that the Government will seek the co-operation of the States and supply extra finance to the States to enable (1) proper town planning and development to halt the increase in densely populated areas which lead to increased crime, (2) the proper staffing and equipping of police forces to enable adequate crime prevention and detection measures to reduce the frightening increase of both solved and unsolved crime, (3) the proper detention and rehabilitation of criminals and (4) compensation to victims of crimes of violence.
 - Mr Enderby presented a petition from certain residents of the Australian Capital Territory praying that a committee of inquiry, on which are represented the Department of Education and Science, institutions of tertiary education, practising educators, and the Canberra community, be instituted to inquire into the form that an Australian Capital Territory Education Authority should take, the educational principles and philosophy that should underly it, and its mode of operation and administration.
 - Mr Berinson and Mr Bennett each also presented a petition from certain citizens of Australia praying that this House give earnest consideration to the crisis in Aboriginal welfare which exists in the South West Land Division of Western Australia.
 - Mr Enderby also presented a petition from certain citizens of the Australian Capital Territory praying that the words "or for preventing conception" be deleted from sub-section (1.) of section 46 of the A.C.T. Pharmacy Ordinance.
 - Mr Kennedy presented a petition from the Bendigo Citizens for Pakistani Refugee Relief Appeal praying that the Government will (1) increase its aid to the Pakistani refugees to \$10 million dollars, (2) grant income tax deductibility for donations to overseas aid organisations and (3) endeavour by diplomatic initiatives to seek a just and humane solution to the problem of the refugees.
