## THURSDAY, 9 DECEMBER 1971

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 Petitions: Mr Wentworth (Minister for Social Services) and Mr Calder each presented a petition from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
  - Mr Stewart, Mr L. K. Johnson and Mr Martin each presented a petition from certain citizens of the Commonwealth praying that the Government (1) immediately increase Australia's contribution to the refugee appeal by \$10 million and (2) press for a just solution to the conflict, so that the refugees may return to their homes.
  - Mr Morrison and Mr Cope each presented a petition from certain citizens of the Commonwealth praying that the Government immediately provide \$10 million in direct aid to refugees now in India and commit itself to a continuing aid programme.
  - Mr Reid presented a petition from certain citizens of Australia praying that the Government take steps to offer employment, at least on a temporary basis, in order to effect some relief, to academic and qualified persons among the refugees from Bangla Desh.
  - Mr Bennett presented a petition from certain citizens of the Commonwealth praying that the sales tax and customs duties on all forms of contraceptive devices be removed, and that all contraceptive devices be placed on the National Health Scheme Pharmaceutical Benefits list.

Petitions severally received.

Mr Bryant presented a petition from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.

Petition received and read.

Mr Lloyd presented a petition from certain citizens of Australia praying that the Government will (1) immediately increase aid, monetary or otherwise, for Pakistani refugee relief to the value of \$10 million, (2) grant as aid, on a continuing basis, a percentage of the gross national product and (3) use every diplomatic channel possible to ease tension between the Indian and Pakistani Governments.

Petition received.

Mr Bennett also presented a petition from certain residents of Western Australia praying that action be taken to move the Perth Airport from its present site. Petition received and read.

3 QUESTIONS: Questions without notice were asked.

4 Suspension of standing orders moved-Motion without notice: Mr Patterson moved-That so much of the standing orders be suspended as would prevent the honourable Member for Dawson (Mr Patterson) moving a motion to establish a select committee to inquire into and report upon the area management proposals of the Postmaster-General's Department, the constant closing of country post offices and similar policies adversely affecting the customers and staff of the Australian Post Office.
