### TUESDAY, 22 FEBRUARY 1972

- 1 The House met, at three o'clock p.m., according to the terms of the resolution of 10 December 1971. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (MR D. O. WATKINS): Mr Speaker informed the House of the death, on 17 December 1971, of Mr David Oliver Watkins, a Member of this House for the Division of Newcastle from 1935 to 1958.
  - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 3 Petitions: Mr Fairbairn (Minister for Defence), Mr Whitlam (Leader of the Opposition) and Mr Dobie each presented a petition from certain citizens of Australia praying that this House will (1) take immediate steps to make emergency finance available to the States for State school education and (2) divert the large sums of public money being spent on private schools to the government school system for which the Government is truly responsible.
  - Mr Garrick presented a petition from certain citizens of the community of the University of Western Australia praying that the Government take immediate action to introduce in order of priority (1) universal Commonwealth scholarships, (2) Commonwealth scholarships on the basis of need rather than academic ability and (3) the abolition of tertiary fees.
  - Mr Whittorn and Mr Fox each presented a petition from certain citizens of the Commonwealth praying that the Government (1) give immediate aid of at least \$10 million to help relieve the suffering of Pakistani refugees in India, (2) take the necessary diplomatic steps to seek a political solution and (3) urge the United Nations to make a more effective effort to intervene on behalf of these stricken people.
  - Mr Fox also presented a petition from certain residents of Victoria praying that this House grant humanitarian aid to the State of Bangla Desh and officially recognise this State as soon as possible.

Petitions severally received.

Mr L. R. Johnson presented a petition from certain citizens of Australia praying that this House take immediate steps to ensure that emergency finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Petition received and read.

Leave granted for debate to ensue.

Mr Hayden moved, as an amendment—That all the words after "That" be omitted with a view to inserting the following words in place thereof: "whilst not opposing the provisions of the Bill, this House is of opinion that the vast majority of those currently unemployed have become unemployed as a direct result of Government economic policies and accordingly directs the Government to prepare a Bill for presentation to this House within 14 days which provides for unemployment benefits not below the updated poverty level established by the 1966 survey of the University of Melbourne's Institute of Applied Economic and Social Research".

Debate continued.

Debate adjourned (Mr Foster), and the resumption of the debate made an order of the day for the next sitting.

11 ADJOURNMENT: Mr Wentworth (Minister for Social Services) moved—That the House do now adjourn.
