THURSDAY, 31 AUGUST 1972

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Brown, Mr Fulton, Mr Grassby, Mr Gun, Mr Hamer, Mr Jacobi, Mr Jarman, Mr Killen, Mr Lloyd, Mr MacKellar, Mr Nicholls and Mr Reid—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
 - Mr Everingham and Mr Uren—from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.
 - Mr Anthony (Minister for Trade and Industry)—from certain electors of the Commonwealth praying that this House will grant (1) an education allowance to the children of civilian widows who are in receipt of social service benefits and (2) the standard rate of pension to 'B' class civilian widows.
 - Mr Bennett—from certain residents of Western Australia praying that the House will take immediate steps to grant taxation concessions to mothers who are forced to pay fees to have their children retained in day care and family care centres.
 - Mr Bennett—from certain residents of Western Australia praying that the Government give urgent consideration to the return of land, compulsorily acquired from the Shire of Belmont for defence purposes, so that proper planning and development of the Shire can continue.
 - Mr Bennett—from certain citizens of the Commonwealth praying that this House make legal provision for (1) a joint Commonwealth-State inquiry into inequalities in Australian education, (2) the immediate financing of special programmes for low income earners and others and (3) the provision of pre-school opportunities for all children.
 - Mr Enderby—from certain employees in Parliament House, Canberra, praying that an early decision will be taken by the Government to build the new and permanent Parliament House which will, in the long run, be a more economical way to house the Parliament and which will at the same time be an impressive and proud symbol of Australia's progress and national unity.
 - Mr Klugman—from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.
 - Mr Klugman—from certain citizens of Australia praying that this House provide the finance to enable State Education Departments and local government authorities to establish pre-school and after-school centres and facilities for training the staff for these centres.
