HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

No. 190

TUESDAY, 12 SEPTEMBER 1972

- 1 The House met, at eleven o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable Sir William Aston) took the Chair, and read Prayers.
- 2 DEATH OF PRINCE WILLIAM OF GLOUCESTER—REPLY TO ADDRESS OF CONDOLENCE: Mr Speaker informed the House that, in reply to the Address of Condolence agreed to by the House on the death of His Royal Highness Prince William of Gloucester, Her Majesty The Queen had sent the following message:

"I am most grateful to the Members of the Senate and the Members of the House of Representatives for their kind message of sympathy on the death of Prince William.

- 3 DISTINGUISHED VISITORS: Mr Speaker informed the House that present in the gallery were delegates attending the First Australian Parliamentary Seminar arranged by the Commonwealth and State Branches of the Commonwealth Parliamentary Association. On behalf of the House, Mr Speaker extended to the visitors a warm welcome.
- 4 INCIDENTS AT MUNICH OLYMPIC GAMES: Mr McMahon (Prime Minister) moved, by leave—
 That this House expresses its horror and shock at the violence which was perpetrated upon competitors and officials at Munich and which threatened to destroy the spirit of the 1972 Olympic Games. The House extends its deepest sympathies to the families and relatives of the deceased, and calls upon all countries which participated in the Games to preserve this unique institution from attacks on its competitors and its ideals.

Debate ensued.

Question—put and passed.

5 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:

Mr Anthony (Minister for Trade and Industry), Mr Fairbairn (Minister for Defence), Mr Beazley, Mr Brown, Mr Calwell, Mr Dobie, Mr Fox, Mr Gun, Mr Hallett, Mr Jess, Mr Reid and Mr Solomon—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.

- Mr Armitage, Mr Klugman and Mr Luchetti—from certain residents of the western suburbs in the Sydney metropolitan area and surrounding districts praying that this House take appropriate steps to ensure that the Government does not proceed with the proposal to site the second twenty-four hour international airport for Sydney at Richmond or anywhere else in the far western suburbs of the metropolitan area.
- Mr Enderby—from certain employees in Parliament House, Canberra, praying that an early decision will be taken by the Government to build the new and permanent Parliament House which will, in the long run, be a more economical way to house the Parliament and which will at the same time be an impressive and proud symbol of Australia's progress and national unity.
- Mr Everingham—from certain citizens of the Commonwealth praying that the Federal Government take immediate steps to act on behalf of all Australian people to preserve Lake Pedder in its natural state.

Mr Klugman—from certain citizens of Australia praying that this House provide the finance to enable State Education Departments and local government authorities to establish pre-school and after-school centres and facilities for training the staff for these centres.

Bowen (Minister for Foreign Affairs), Mr Sinclair (Minister for Primary Industry) was acting as Minister for Foreign Affairs and would represent the Attorney-General in the House.

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Garland (Minister assisting the Treasurer), the Bill was read a third time.

12 INCOME TAX ASSESSMENT BILL (No. 4) 1972 [No. 2]: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

The House resolved itself into a committee of the whole.

On the motion of Mr Garland (Minister assisting the Treasurer), the following amendment was made: Clause 1, pages 1 and 2, omit the clause, insert the following clause:

- "1.—(1.) This Act may be cited as the *Income Tax Assessment Act* Short title and citation. (No. 5) 1972.
- "(2.) The Income Tax Assessment Act 1936-1971,* as amended by the Income Tax Assessment Act 1972,† by the Income Tax Assessment Act (No. 2) 1972,‡ by the Income Tax Assessment Act (No. 3) 1972§ and by the Income Tax Assessment Act (No. 4) 1972,¶ is in this Act referred to as the Principal Act.
- "(3.) Section 1 of the *Income Tax Assessment Act* (No. 4) 1972 is amended by omitting sub-section (4.).
- "(4.) The Principal Act, as amended by this Act, may be cited as the *Income Tax Assessment Act* 1936-1972.".

Bill, as amended, agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Garland, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

- "(4.) The Principal Act, as amended by this Act, may be cited as the Sales Tax (Exemptions and Classifications) Act 1935-1972.".
- Clause 3, page 2, lines 1 and 2, omit "Sales Tax (Exemptions and Classifications)

 Act 1935-1970", insert "Principal Act".

Clause 4, page 2, lines 11 and 12, omit "Sales Tax (Exemptions and Classifications)

Act 1935-1970", insert "Principal Act".

Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr Lucock reported accordingly.

On the motion of Mr Garland, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

14 EXPORT PAYMENTS INSURANCE CORPORATION BILL 1972: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 252, dated 23 August 1972, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Holten (Minister for Repatriation), the Bill was read a third time.

15 THIRTY-FIVE HOUR WORKING WEEK—MINISTERIAL STATEMENT—MOTION TO TAKE NOTE OF PAPER: Mr McMahon (Prime Minister), by leave, made a ministerial statement relating to the Government's attitude to the introduction of a thirty-five hour working week throughout industry, and, by command of His Excellency the Governor-General, presented the following paper:

Thirty-five hour working week-Ministerial statement, 12 September 1972.

Mr Chipp (Leader of the House) moved—That the House take note of the paper.

Debate ensued.

Ordered-That Mr C. R. Cameron be granted an extension of time.

Debate continued.

Debate adjourned (Mr Giles), and the resumption of the debate made an order of the day for the next sitting.

16 APPROPRIATION BILL (No. 1) 1972-73: The House, according to order, resolved itself into a committee of the whole for the further consideration of the Bill.

17 TRESPASS ON COMMONWEALTH LANDS ORDINANCE 1972—VALIDATION—MINISTERIAL STATEMENT: Mr Hunt (Minister for the Interior), by leave, made a ministerial statement relating to the validation of the *Trespass on Commonwealth Lands Ordinance* 1972 of the Australian Capital Territory.

Mr Crean, Mr Enderby, Mr Sinclair (Minister representing the Attorney-General) and Mr Whitlam (Leader of the Opposition), by leave, also made statements with reference to the matter.

18 ADJOURNMENT: Mr Chipp (Leader of the House) moved—That the House do now adjourn.

Debate ensued.
