# THURSDAY, 3 MAY 1973

- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:

  - Sir John Cramer, Mr Graham and Mr Wentworth—from certain citizens of Australia praying that the House will not extend the laws governing abortion and will uphold the right to life of the unborn child.
  - Mr Lynch—from certain electors of the Division of Flinders of various faiths, in terms similar to the petition lodged by Sir John Cramer.
  - Mr Jarman-from certain citizens of the Commonwealth praying that the House should maintain the existing laws covering abortion.
  - Mr Mathews—from certain citizens of the Commonwealth praying that Australia's official development assistance in 1972–73 be increased to at least \$240 million, and that Australia's aid and trade policies be reviewed to benefit developing countries.
  - Mr Viner—from certain citizens of Australia praying that this House take immediate steps to ensure that finance from the Commonwealth will be given to the States for their public education services which provide schooling for 78 per cent of Australia's children.

Mr Peacock, by leave, also made a statement with reference to the matter.

- 7 PRICES—JOINT COMMITTEE—REFERENCE—IMPORTS AFFECTED BY REVALUATION: Mr Crean (Treasurer) moved, pursuant to notice—
  - (1) That the following matter be referred to the Joint Committee on Prices: Imports in respect of which evidence is presented to the Committee that the Australian dollar price to consumers or users failed to respond to reductions in landed costs following the revaluation of the Australian dollar in December 1972 or following other relevant currency changes in 1973, with particular reference to those imports having a significant effect on domestic costs and prices.
  - (2) That a message be sent to the Senate acquainting it of this resolution.
  - Debate ensued.

  - (2) That a message be sent to the Senate acquainting it of this resolution.
  - Debate ensued.

Question-put and passed.

    - (v) the average interest rates, if any, charged upon any loans made during the reporting period;
    - (vi) the amount of repayments due under the conditions of any loan, and the amount of repayments actually made during the reporting period; and
    - (vii) the sufficiency of any grant made to the University for providing assistance to students in need.".
