# HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

# TUESDAY, 8 MAY 1973

1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.

2 Peritions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:

Mr Hayden (Minister for Social Security), Mr Stewart (Minister for Tourism and Recreation), Mr Connor (Minister for Minerals and Energy), Mr L. R. Johnson (Minister for Housing), Dr Everingham (Minister for Health), Mr Sinclair (Deputy Leader of the Australian Country Party), Mr Adermann, Mr Bennett, Mr Bourchier, Mr Calder, Mr D. M. Cameron, Mr Cross, Mr Davies, Mr Drury, Mr Erwin, Mr FitzPatrick, Mr Fraser (4), Mr Giles, Mr Hallett, Mr Hamer, Mr Hewson, Mr Holten, Mr Jarman, Mr Katter, Mr Keating, Mr Kerin (2), Mr Luchetti (2), Mr Lucock (5), Mr McLeay, Mr McVeigh, Mr Maisey, Mr Olley, Mr Riordan, Mr Scholes, Mr Viner, Mr Wallis, Mr Whan and Mr Wilson—from certain citizens of Australia praying that the House should not admit into the law of this land a principle which violates the fundamental right to life.

Mr Hayden, Mr Kerin, Mr Luchetti and Mr Martin—from certain citizens of Australia praying that the House will not extend the laws governing abortion and will uphold the right to life of the unborn child.

Mr FitzPatrick and Mr Whan—from certain citizens of New South Wales and certain electors of the Division of Eden-Monaro, respectively, in terms similar to the last preceding petition.

Mr Bourchier, Mr Hamer and Mr Jarman—from certain citizens of the Commonwealth praying that the House should maintain the existing laws covering abortion.

Mr Connor—from certain citizens of Australia praying that the House urge the Government to seek the release of all political prisoners in South Vietnam, urge speedy trials for all those held on political charges and to arrange for an international inspection of conditions in gaols in South Vietnam, particularly political prisons.

Mr Gorton—from certain citizens of the Division of Higgins praying that the House oppose any legislation which would liberalise abortion in any circumstances.

Petitions received.

3 MINISTERIAL ARRANGEMENTS AND ANNOUNCEMENT OF DEPUTY LEADER OF THE HOUSE: Mr Whitlam (Prime Minister) informed the House of the following ministerial arrangements during the respective absences abroad of Mr Barnard (Minister for Defence) and Dr Cairns (Minister for Overseas Trade and Minister for Secondary Industry):

Senator Bishop (Minister for Repatriation) was acting as Minister for Defence and would be represented in both capacities in this House by Mr Whitlam;

Dr Patterson (Minister for Northern Development) would act as Minister for Overseas Trade; and

Mr Connor (Minister for Minerals and Energy) would act as Minister for Secondary Industry and would represent the Minister for Customs and Excise in this House.

Mr Whitlam also informed the House that Mr L. F. Bowen (Postmaster-General) would be Deputy Leader of the House.
