- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:
 - Mr Morrison (Minister for Science), Mr Sinclair (Deputy Leader of the Australian Country Party), Sir John Cramer, Mr Duthie, Mr Edwards, Mr Luchetti, Mr Nixon, Mr Turner and Mr Wentworth—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.
 - Mr Bonnett, Mr D. M. Cameron, Mr Cooke, Mr Drury, Mr Giles, Mr Killen, Mr McLeay, Mr McVeigh and Mr E. L. Robinson—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
 - Mr Gorton, Mr Mathews, Mr Peacock and Mr Street—from certain citizens of Australia praying that the House acknowledge the right of every Australian child to equal grants of Government money spent on education.
 - Mr Cooke—from certain citizens of Australia praying that the House urge the Government to give moral support to the Jewish cause in the Middle East crisis.
 - Mr Edwards—from certain citizens of Australia praying that the House take stepsto ensure that the Government does not site a second international airport for Sydney in the Galston area or surrounding suburbs.
 - Mr Edwards—from certain citizens of the Commonwealth praying that the House will at once take steps to dedicate as a National Park an area of at least 1,436 square miles as recommended by the Northern Territory Reserves Board.
 - Mr FitzPatrick—from certain citizens of Australia praying that the House move to make available to the New South Wales and Victorian Governments a special grant for the construction of a bridge over the Murray River linking Buronga, New South Wales, and Mildura, Victoria.
 - Mr Viner—from certain residents of Perth praying that the Army and the Government do not release land at Swanbourne, Western Australia, or make any decision concerning the proposed road along the coast until an environmental impact study has been taken.

Page 9, after clause 32, insert the following new clause:

"32A. The Seventh Schedule to the Principal Act is amended by Seventh Schedule. omitting the words 'that I will be faithful and bear true allegiance to

Her Majesty Queen Elizabeth the Second, Her Heirs and Successors according to law, that I will well and truly serve Her' (wherever occurring) and substituting the words 'that I will well and truly serve'.".

On the motion of Mr Morrison (Minister for External Territories), the amendment was agreed to, after debate.
