THURSDAY, 22 NOVEMBER 1973

1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following honourable Members had each lodged petitions for presentation, viz.:

Mr Sinclair (Deputy Leader of the Australian Country Party), Mr Martin, Mr Morris, Mr O'Keefe, Mr Ruddock and Mr Turner—from certain citizens of Australia praying that the House see that television is used to build into the nation integrity, teamwork and a sense of purpose by serving, and to bring faith in God to the heart of the family and national life.

Mr Kerin—from certain citizens of Australia praying that the House immediately revoke all Australian whaling licences and ban the importation of all whale produce.

Mr King—from certain citizens of Australia praying that the House urge the Government to include "God Save The Queen" in any referendum or poll to decide a national anthem.

- 8 GENERAL BUSINESS NOTICE: Upon notice No. 1, general business, being called on, Mr Hunt informed the House that he had fixed general business Thursday No. 12 as the day on which he would move the motion.
- 9 “BLYTHE STAR”—LOCATION OF SURVIVORS—PROPOSED SELECT COMMITTEE: Mr Wentworth moved, pursuant to notice—
- (1) That a select committee of this House be appointed to inquire into:
    - (a) the reasons why the raft with the survivors of the *Blythe Star* was not located more promptly, and
    - (b) possible measures to facilitate the prompt location of boats or rafts in difficulties at sea.
  - (2) That the committee consist of the mover and seconder together with three Members to be nominated by the Prime Minister, and to be notified in writing to the Speaker.
  - (3) That the committee have power to send for persons, papers and records, to move from place to place, and to sit during any recess or adjournment of the Parliament.
  - (4) That the committee report to this House not later than 30 November 1973.
- Debate ensued.  
Motion withdrawn, by leave.
- 10 MINISTER FOR LABOUR—CONDUCT: Mr Wentworth moved, pursuant to notice—That this House requires an explanation and apology from the Minister for Labour for his conduct in misleading it on 16 October as recorded in *Hansard* at pages 2134–2135, in that he falsely reported the advice tendered by an officer of his Department.  
Debate ensued.  
Ordered—That Mr C. R. Cameron (Minister for Labour) be granted an extension of time.  
Debate continued.  
Question—put and negatived.
- 11 MESSAGE FROM THE SENATE—SCHOOLS COMMISSION BILL 1973: The following message from the Senate was reported:

- 12 STATES GRANTS (ADVANCED EDUCATION) BILL (No. 4) 1973: Mr L. F. Bowen (Acting Minister for Education), pursuant to notice, presented a Bill for an Act to amend the *States Grants (Advanced Education) Act (No. 3) 1972* as amended by the *States Grants (Advanced Education) Act 1973* and the *States Grants (Advanced Education) Act (No. 3) 1973*.

Bill read a first time.

Mr Bowen moved—That the Bill be now read a second time.

Debate adjourned (Mr Sinclair—Deputy Leader of the Australian Country Party), and the resumption of the debate made an order of the day for the next sitting.

- 13 WHEAT INDUSTRY STABILIZATION BILL 1973: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

*Message from the Governor-General:* Message No. 98, dated 10 October 1973, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

The House resolved itself into a committee of the whole.

In the committee

Clauses 1 to 7, by leave, taken together, and agreed to.

*Proposed new clause—*

Mr Sinclair (Deputy Leader of the Australian Country Party) moved—That the following new clause be inserted in the Bill:

“7A. Section 13 of the Principal Act is amended by omitting sub-section (3) and substituting the following sub-sections: Powers of Board.

‘(3) The Minister may disallow a sale or disposal or agreement for the sale or disposal of wheat, wheaten flour, semolina, corn sacks, jute or jute products which in his opinion provides for a price or conditions which would provide for less than a reasonable market return.

‘(3A) The Minister shall table in both Houses of the Parliament within fifteen sitting days of a disallowance of a sale or disposal or agreement for the sale or disposal of wheat, wheaten flour, semolina, corn sacks, jute or jute products a statement of the reasons of which his disallowance was based.’”.

Debate ensued.

Question—That the new clause proposed to be inserted be so inserted—put.

19 MESSAGE FROM THE SENATE—HIGH COMMISSIONER (UNITED KINGDOM) ACT REPEAL BILL 1973: Message No. 169, dated 22 November 1973, from the Senate was reported transmitting for the concurrence of the House a Bill for “*An Act to repeal the ‘High Commissioner (United Kingdom) Act 1909–1966’, and for purposes connected therewith*”.

Bill read a first time.

Mr Daly (Leader of the House) moved, by leave—That the second reading be made an order of the day for a later hour this day.

Question—put and passed.

20 MESSAGE FROM THE SENATE—CUSTOMS BILL 1973: Message No. 170, dated 22 November 1973, from the Senate was reported transmitting for the concurrence of the House a Bill for “*An Act to amend section 131A of the ‘Customs Act 1901–1971’*”.

Bill read a first time.

Ordered—That the second reading be made an order of the day for the next sitting.

21 INCOME TAX ASSESSMENT BILL (No. 4) 1973: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Crean (Treasurer), the Bill was read a third time.

22 INCOME TAX ASSESSMENT BILL (No. 5) 1973: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

*Suspension of standing orders—Extended time for speech:* Mr Crean (Treasurer) moved, by leave—That so much of the standing orders be suspended as would prevent Mr Lynch (Deputy Leader of the Opposition) speaking without limitation of time.

Question—put and passed.

Debate resumed by Mr Lynch who moved, as an amendment—That all words after “That” be omitted with a view to inserting the following words in place thereof: “whilst not declining to give the Bill a second reading, the House is of the opinion that the provisions of the Bill are a contravention of the Government’s electoral undertakings not to increase taxes and that the Bill specifically:

(a) imposes unwarranted taxes on pensioners;

(b) eliminates incentives for manufacturing industry inconsistent with the economic requirement to increase productivity and ease the pressure on domestic resources;

(c) removes or drastically reduces important rural productivity incentives;

(d) jeopardises the savings and future security of Australians holding life assurance policies;

(e) places inflexible rules on the sale of property which take no account of reasons unconnected with profit motives such as illness and additional family responsibilities;

(f) impedes the development of small businesses by increasing the rates of private company tax, and

(g) places added cost burdens on Australia’s wine and brandy producers especially the smaller producers of wine grapes”.
