## SECOND SESSION OF THE TWENTY-EIGHTH PARLIAMENT

## THURSDAY, 28 FEBRUARY 1974

1 Members of the House assembled at three o'clock p.m., pursuant to the Proclamation of His Excellency the Governor-General, dated 14 February 1974, which Proclamation was read at the Table by the Clerk, as follows:

### **PROCLAMATION**

Australia
PAUL HASLUCK
Governor-General.

By His Excellency the Governor-General of Australia.

Whereas by the Constitution it is amongst other things provided that the Governor-General may appoint such times for holding the Sessions of the Parliament as he thinks fit, and may also, from time to time, by Proclamation or otherwise, prorogue the Parliament:

Now therefore, I, Sir Paul Meernaa Caedwalla Hasluck, the Governor-General of Australia, do by this my Proclamation prorogue the Parliament until Thursday, 28 February 1974 or (in the event of circumstances arising, at present unforeseen, which render it expedient that the Parliament should be summoned to assemble on a day earlier than that day) to such earlier day as is fixed by a Proclamation summoning the Parliament to assemble and be holden for the despatch of business:

Furthermore I do appoint the said Thursday, 28 February 1974, or such earlier day (if any) as is fixed by Proclamation, as the day for the Parliament to assemble and be holden for the despatch of business:

And all Senators and Members of the House of Representatives are hereby required to give their attendance accordingly in the building known as Parliament House, Canberra, at the hour of three o'clock in the afternoon, on Thursday, 28 February 1974, or, in the event of an earlier day being fixed by Proclamation, at the time fixed by that Proclamation on the day so fixed.

- 6 ADDRESS IN REPLY TO THE SPEECH OF HER MAJESTY THE QUEEN: Mr Whitlam (Prime Minister) moved—That a committee, consisting of Mr Riordan, Mr McKenzie and the mover be appointed to prepare an Address in Reply to the Speech delivered by Her Majesty The Queen to both Houses of the Parliament, and that the committee do report at the next sitting.

7 ADJOURNMENT: Mr Daly (Leader of the House) moved—That the House do now adjourn. Question—put and passed.
