- 1 The House met, at fifteen minutes past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 MOTION OF CENSURE OF GOVERNMENT—PRECEDENCE TO NOTICE OF MOTION: Mr Daly (Leader of the House) informed the House that he accepted the notice of motion given on 18 July by Mr Anthony (Leader of the Australian Country Party) as a motion of censure of the Government for the purposes of standing order 110.
- 3 MOTION OF CENSURE OF GOVERNMENT: Mr Anthony (Leader of the Australian Country Party) moved, pursuant to notice—That the Government be censured—
 - (1) for its failure to observe proper Parliamentary procedures which would require the honourable Member for Eden-Monaro to substantiate serious allegations he has made inside and outside the Parliament reflecting on the integrity of the members and staff of the Australian Wool Corporation and the Leader and Deputy Leader of the Australian Country Party,
 - (2) for its tacit support of the allegations made by the honourable Member for Eden-Monaro of a conspiracy between the Leader and Deputy Leader of the Australian Country Party and three unnamed members of the Australian Wool Corporation and involving senior staff of the Corporation to support the price of wool at excessively high levels in order to embarrass the Government,
 - (3) for its refusal to support proposals intended to require the honourable Member for Eden-Monaro to produce the written evidence he claims to possess in relation to his charge, and
 - (4) for prejudicing the future marketing of the Australian wool clip through permitting uncertainty to exist as to the integrity of the Australian Wool Corporation thereby creating doubt as to its future commercial operations.

Debate ensued.

Mr Beazley (Minister for Education), Mr Bennett, Mr Berinson, Mr Dawkins and Mr Garland—from certain citizens of Australia praying that Parliament (1) take any steps necessary either to direct the Commonwealth Banking Corporation to preserve and restore the Palace Hotel, St George's Terrace, Perth, or itself to acquire, preserve and restore the hotel on its present site and (2) make available any funds necessary to purchase the entire contents of the hotel from the owners.

- Mr Whitlam (Prime Minister), Mr Connor (Minister for Minerals and Energy) and Mr Street—from certain citizens of Australia praying that the Government take no measures to interfere with existing television program standards or to permit easier entry into Australia, or production in Australia, of pornographic material.
- Mr Drury, Mr McLeay and Mr Wilson—from certain citizens of Australia praying that the Government take no measures to interfere with the existing national health scheme.
