## WEDNESDAY, 27 NOVEMBER 1974

- 1 The House met, at twelve o'clock noon, pursuant to adjournment. Mr Speaker (the Honourable J. F. Cope) took the Chair, and read Prayers.
- 2 DEATH OF U THANT: Mr Whitlam (Prime Minister) referred to the death of U Thant, former Secretary-General of the United Nations, paid tribute to his service to the United Nations and expressed the condolences of the Government and the people of Australia to his widow and daughter.
  - Mr Lynch (Deputy Leader of the Opposition), on behalf of the Opposition parties, joined in the expression of condolence.
  - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Dawkins and Mr Ruddock—from certain citizens and foreign students in Australia praying that the House ensure the political and other rights of foreign students who study in Australia.
  - Dr Cass (Minister for the Environment and Conservation)—from certain citizens of the Commonwealth praying that the Family Law Bill be debated and passed as soon as possible.
  - Mr Hodges—from certain citizens of Australia praying that the House not admit into the law of this land the principle that marriage is only temporary and the family no longer the fundamental unit of society.
  - Mr McKenzie—from certain citizens of Australia praying that the House take urgent steps to ensure that further mining and export from Australia of uranium, except for bio-medical purposes, be banned and that the Australian Atomic Energy Commission be transformed into an Australian Energy Commission.
  - Mr Peacock—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
  - Mr Peacock—from certain citizens of Australia praying that the House take immediate steps to restore education benefits to parents, at least to the 1973–74 level, either by increasing taxation deductions or through taxation rebates.
  - Mr Whan—from certain citizens of Australia praying that the Government increase substantially humanitarian assistance to national liberation movements in Africa.

- 7 PECUNIARY INTERESTS OF MEMBERS OF THE PARLIAMENT—JOINT COMMITTEE: Mr Bowen (Special Minister of State) moved, by leave—
  - (1) That paragraph (12) of the resolution of appointment of the Joint Committee on Pecuniary Interests of Members of the Parliament be omitted and that the following paragraph be substituted:
    - "(12) That the committee report within the shortest reasonable period, not later than 29 May 1975, and that any member of the committee have power to add a protest or dissent to any report.".
  - (2) That a Message be sent to the Senate requesting its concurrence.
