- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Jones (Minister for Transport) and Mr Drury—from certain citizens of Australia praying that the House amend the Family Law Bill.
 - Mr Fisher and Mr Graham—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
 - Mr Lloyd and Mr Mathews—from certain citizens of Australia praying that the House pass the Family Law Bill.
 - Mr Drury—from certain citizens of Australia praying that the Government reduce the cost of the subscription to *Hansard*.
 - Dr Edwards-from certain citizens of Australia praying that the Government restore to \$400 the amount deductible against income tax for education expenses.
 - Mr Fry—from certain citizens of Canberra praying that (1) the House ensure that the proposed construction of low-cost accommodation in Reid, A.C.T., does not proceed until the matter has been re-assessed and (2) this petition be referred to the Joint Committee on the Australian Capital Territory.
 - Mr McKenzie—from certain citizens of Australia praying that the House immediately revoke all Australian whaling licences and ban the importation of all whale produce.
