TUESDAY, 8 APRIL 1975

1 The House met, at fifteen minutes past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.

2 **PETITIONS:** The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr L. R. Johnson (Minister for Housing and Construction), Mr Morrison (Minister for Science), Mr Stewart (Minister for Tourism and Recreation), Mr K. M. Cairns, Mr England, Mr Giles, Mr Howard, Mr Hunt, Mr Killen, Mr Lamb, Mr Lucock, Mr Lusher, Mr McMahon, Mr Riordan, Mr Thorburn, Mr Wentworth, Mr Whan and Mr Wilson—from certain citizens of Australia praying that the House amend the Family Law Bill.

Mr Anthony (Leader of the Australian Country Party), Mr Bonnett, Dr Forbes, Mr Giles, Mr Howard, Mr King, Mr Lamb, Mr McKenzie, Mr O'Keefe, Mr E. L. Robinson, Mr Wentworth, Mr Willis and Mr Wilson—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.

Mr Barnard (Minister for Defence) and Mr Drury—from certain citizens of Australia praying that the Government reduce the cost of the subscription to *Hansard*.

Mr L. R. Johnson and Mr Thorburn—from certain citizens of Australia praying that an urgent capital grant be made from the Australian Schools Commission for the establishment of a Catholic High School at Engadine, New South Wales.

Mr Enderby (Attorney-General)—from certain citizens of Australia praying that the House pass the Family Law Bill.

Mr Garland—from certain citizens of Australia praying that the House provide for the recognition of qualified and responsible persons engaged in the profession of natural therapeutics.

Mr Luchetti—from certain citizens of Australia praying that the Government (1) grant a cash loading to pensioners, (2) increase within a reasonable period the weekly pension to 25 per cent of average weekly earnings, (3) freeze the tapered means test ceilings of income and assets and (4) give an assurance that the proposed national superannuation Bill will provide pensioners with a guaranteed minimum income of 30 per cent of quarterly adjusted average weekly earnings.

Mr Lusher—from certain citizens of Australia praying that the House oppose the Family Law Bill.

Mr Martin—from certain citizens of Australia praying that the Government (1) cease the mining and export of uranium until safe disposal methods have been guaranteed, (2) increase expenditure on research into clean and inexhaustible sources of energy and (3) aid underdeveloped countries in their plea for a share of world energy resources.

Petitions received.

3 **MINISTERIAL CHANGE:** Mr Whitlam (Prime Minister) informed the House that His Excellency the Governor-General had determined the appointment of Mr Enderby as Minister for Customs and Excise and had appointed him as Minister for Police and Customs.

4 **LEADERSHIP AND WHIPS OF THE LIBERAL PARTY OF AUSTRALIA:** Mr Fraser, as Leader of the Opposition, informed the House that the Parliamentary Liberal Party had elected him as its Leader, Mr Lynch remained as Deputy Leader, Mr Bourchier had been appointed Opposition Whip and Mr D. M. Cameron remained as Liberal Party Deputy Whip.

Mr Whitlam (Prime Minister) congratulated Mr Fraser, who made his acknowledgment.

7 **INDO-CHINA—MINISTERIAL STATEMENT—PAPER NOTED:** Mr Whitlam (Prime Minister), by leave, made a ministerial statement relating to the conflict in Indo-China and Australia's humanitarian involvement in the war, and, by command of His Excellency the Governor-General, presented the following paper:

Indo-China—Ministerial statement, 8 April 1975.

Mr Daly (Leader of the House) moved—That the House take note of the paper.

*Suspension of standing orders—Extended time for speech:* Mr Daly moved, by leave—

That so much of the standing orders be suspended as would prevent Mr Fraser (Leader of the Opposition) speaking for a period not exceeding 27 minutes.

Question—put and passed.

Debate ensued.

Mr Killen moved, as an amendment—That the following words be added to the motion: "and calls upon the Government to provide more meaningful aid and assistance to refugees in the Khmer Republic and South Vietnam and at the same time calls upon the Australian Government to seek a cease-fire in both the Khmer Republic and South Vietnam and urges that:

- (1) the Government approach North Vietnam to seek observance of the Paris Agreement and permit Red Cross, Red Crescent and United Nations inspection teams to be present in areas held by North Vietnam;
- (2) the Government approach the USSR and China to seek observance of the Paris Agreement;

- (3) the Government approach other countries to build pressure (a) to seek observance of the Agreement, and (b) to persuade other governments of the urgency of providing aid in Vietnam;
- (4) the Australian Government approach the United Nations (a) to get the UN agreement to achieve support for UN action in South Vietnam, and (b) to maximise support for refugees which involves the support of the UN High Commission for Refugees;
- (5) the Government expand its own in-country support to South Vietnam in food, clothing and medical supplies;
- (6) the Government plan to take into Australia some thousands of refugees, including orphans, if consultations with South Vietnam indicate that this is a desirable course;
- (7) the Government plan for continuing civil aid in South Vietnam even in areas over-run by the North—but on condition that UN inspection teams, or appropriate voluntary agencies, supervise the use of aid in support of refugees, and
- (8) the Government provide additional support for voluntary agencies in their relief work ”.
