- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Barnard (Minister for Defence), Mr Bonnett, Mr Coates, Mr Corbett, Mr Drury, Mr Duthie, Mr Gorton, Mr Hodges, Mr Keogh, Mr Killen, Mr Macphee, Mr Nixon and Mr Reynolds—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
 - Mr Connolly, Mr Gorton, Mr Hodges, Mr Macphee and Mr Street—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
 - Mr Clayton, Mr Drury, Mr Jacobi, Mr Riordan and Mr Ruddock—from certain employees and agents of the Australian insurance industry, in terms similar to the last preceding petition.
 - Mr Coates—from certain citizens of Australia praying that the House take urgent steps to ensure that further mining and export from Australia of uranium, except for bio-medical purposes, be banned and that the Australian Atomic Energy Commission be transformed into an Australian Energy Commission.
 - Mr Drury—from certain citizens of Australia praying that the House amend the Family Law Bill.
 - Mr Howard—from certain citizens of Australia praying that the Government (1) cease the mining and export of uranium until safe disposal methods have been guaranteed, (2) increase expenditure on research into clean and inexhaustible sources of energy and (3) aid underdeveloped countries in their plea for a share of world energy resources.
 - Mr Morris—from certain citizens of Australia praying that the Government finance the establishment of a fauna and flora sanctuary at Black Neds Bay, New South Wales.

The Senate amendments have the effect of removing from this Bill the opportunity of the Australian Government on the approval of the Minister to fund direct local governments, charitable or benevolent organisations, community groups and other organisations, including research, on conditions determined by the Commission.

Mr Bowen moved—That the committee's reasons be adopted. Question—put and passed.

25 HOUSING LOANS INSURANCE BILL 1975: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr McLeay who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "to enable the provisions of the Bill to be more adequately considered, the House is of opinion that further progress of the Bill should be deferred until the Budget sittings 1975".

Debate continued.

Mr McVeigh addressing the House-

Remainder of Bill, by leave, taken as a whole, and agreed to.
