- 1 The House met, at ten o'clock a.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Bungey, Mr Connolly, Mr Fisher and Mr McLeay—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
 - Mr Cadman, Mr Connolly, Mr Dawkins and Mr Newman—from certain citizens of Australia praying that the House either decrease or reject proposed increases in postal and telephone charges.
 - Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.
 - Mr McMahon—from certain citizens of Australia praying that the subsidy on postal charges to the religious, charitable and trade union press be increased.
 - Mr Nixon—from certain citizens of Australia praying that the House grant \$200,000 to the Shire of South Gippsland, Victoria, for maintenance of services at the 1972 level and that it increase this grant annually in line with the inflation rate.
 - Mr Snedden—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
