- 1 The House met, at fifteen minutes past two o'clock p.m., pursuant to adjournment. Mr Speaker (the Honourable G. G. D. Scholes) took the Chair, and read Prayers.
 - 2 COMMONWEALTH PARLIAMENTARY ASSOCIATION—DELEGATION FROM THE UNITED KINGDOM: Mr Speaker informed the House that a delegation from the United Kingdom Branch of the Commonwealth Parliamentary Association, led by Mr G. A. T. Bagier, M.P., was present in the gallery. On behalf of the House, Mr Speaker extended to the delegation a very warm welcome.
 - 3 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Stewart (Minister for Tourism and Recreation), Mr Bonnett, Mr K. M. Cairns, Mr D. M. Cameron, Mr Drury, Mr Hodges, Mr Killen, Mr McVeigh and Mr E. L. Robinson—from certain citizens of Australia praying that the cadet corps be continued.
 - Mr Cross, Mr Jarman, Mr Kerin, Mr Mathews, Mr Morris and Mr O'Keefe—from certain citizens of Australia praying that the House ensure that the Government (1) prohibit the export of mineral sands from Fraser Island and (2) assist the Queensland Government and other bodies to conserve the natural environment of Fraser Island for the benefit of the people of Australia.
 - Mr Connolly, Mr Hyde and Mr Macphee—from certain citizens of Australia praying that the House reject the Australian Government Insurance Office Bill.
 - Mr Ellicott, Mr Hodges and Mr Newman—from certain citizens of Australia praying that no further measures be taken which will make home ownership unattractive to those who have a home and unachievable for those who have not.
 - Mr Enderby (Attorney-General) and Dr Cass (Minister for the Media)—from certain citizens of Australia praying that powers to vary income tax be not given to State Governments.
 - Dr Cass and Mr McVeigh—from certain citizens of Australia praying that the existing statutory time requirements for the televising and broadcasting of religious programs be continued.
 - Mr Corbett and Mr Jarman—from certain citizens of Australia praying that (1) the Metric Conversion Act be repealed and (2) the Government take urgent steps to cause the traditional and familiar units to be restored in those areas where the greatest inconveniences and distress are occurring.
 - Mr Newman and Mr Staley—from certain citizens of Australia praying that the House either decrease or reject proposed increases in postal and telephone charges.
 - Mr L. R. Johnson (Minister for Aboriginal Affairs)—from certain citizens of Australia praying that (1) pensions be related to average weekly earnings and (2) no charge be made for the installation or rental of telephones for pensioners.
 - Mr Berinson (Minister for Environment)—from certain members of St Philip's Church, Canberra, praying that the declaration of the Kakadu National Park,

Northern Territory, and the development of the nearby Ranger uranium deposits be not proceeded with until the Aborigines in the area have been fully consulted.
 Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on personal residential land and water rates.

Dr Edwards—from certain citizens of Australia praying that the House take action to restore land to Queensland Aborigines and Torres Strait Islanders and nullify the effects of certain Queensland legislation.

Mr Ellicott—from Danny Sankey of Vaucluse, N.S.W., solicitor, praying that the House grant leave to the petitioner and his legal representatives to issue and serve subpoenae for the production of official records of the proceedings of the House held between 2.55 p.m. and 10.09 p.m. on 9 July 1975 and of documents tabled therein and further to issue and serve subpoenae for the attendance in Court of those persons who took the record of such proceedings.

- (1) That the House of Representatives having considered Message No. 275 of the Senate asserts that the action of the Senate in delaying the passage of the Loan Bill 1975 for the reasons given in the Senate resolution is contrary to the accepted means of financing a major portion of the Defence budget of this country and therefore requests the Senate to re-consider and pass the Bill without delay.
- (2) That a message be sent to the Senate acquainting it of this resolution.

Mr Killen moved, as an amendment—That all words after “That” be omitted with a view to substituting the following words: “the House of Representatives endorses Message No. 275 of the Senate, in particular, that the Bill be not further proceeded with until the Government agrees to submit itself to the judgment of the people”.
