- 1. The House met pursuant to adjournment.—Mr. Speaker took the Chair, and read Prayers.
- 2. PRIVILEGE—PROCEDURE IN CASES OF.—Sir John Quick, Chairman, brought up a Progress Report from the Joint Select Committee on Procedure in Cases of Privilege; together with the Minutes of Evidence to date, and Appendices.

 Ordered, after debate, to lie upon the Table and to be printed.
- 3. Cost and Revenue under State and Commonwealth of Transferred Services, etc.—Mr. Dugald Thomson moved, pursuant to notice, That a Return be laid upon the Table of the House showing—
 - (a) The cost to each State, in the year prior to Federation, of each of the services since transferred to the Commonwealth.
 - (b) The revenue, if any, derived by each State from each of such services in the same year.
 (c) The present annual cost to each State of each of the services which are yet to be trans
 - (c) The present annual cost to each State of each of the services which are yet to be transferred to the Commonwealth.
 - (d) The present annual revenue, if any, derived by each State from each of such services not yet transferred.
 - Where, in the accounts of a State, the income or expenditure of a transferred or transferable service has not been separated from that of other services, an approximate estimate to be furnished.

Question—put and resolved in the affirmative.

- 4. Customs and Excise Revenue received and Number and Salaries, etc., of Officers.—Mr. Johnson moved, pursuant to notice, That a Return be laid upon the Table of the House showing—
 - (1) The revenue received from duties of Customs and Excise for each State annually since the passing of the first Commonwealth Tariff Act, including the amount received for the first quarter of the current year.
 - (2) Total amount of salaries paid in each State in respect of the collection of duties for that State.
 - (3) Total number of officers in each State employed by the Department, and how classified.
 - (4) The number and classification of officers, and salaries paid to each, employed in Sydney, Melbourne, Brisbane, Adelaide, Fremantle, Hobart, and Launceston.
 - (5) Salaries paid in connexion with the central administration common to the whole of the Commonwealth. Such salaries not to be included in the returns relating separately to each State.

Question—put and resolved in the affirmative.
