TUESDAY, 1 JUNE 1976

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Garrick, Mr Graham, Mr L. R. Johnson, Mr J. L. McMahon and Mr Morris—from certain citizens of Australia praying that social security payments be adjusted instantly and automatically with increases in the Consumer Price Index and certain other benefits be adjusted.
 - Mr P. F. Johnson and Mr Sainsbury—from certain citizens of Australia praying that the Australian Heritage Commission be appointed urgently and grants be given to community organisations concerned with conservation.
 - Mr Carige—from certain citizens of the Electorate of Capricornia in terms similar to the last preceding petition.
 - Mr Howard (Minister for Business and Consumer Affairs) and Mr Connolly—from certain citizens of Australia praying that a Commission of Inquiry be initiated into the Aurukun Associates Agreement Act, no mining take place on the Aurukun Aboriginal Reserve until a full environmental impact study has been made and an export licence to the consortium concerned be refused until negotiations are held with the Aurukun people and an agreement has been reached.
 - Mr Baillieu and Mr Bryant—from certain citizens of Australia praying that the Australian Assistance Plan be continued as recommended in the report tabled in Parliament on 4 March 1976.
 - Mr Garrick and Mr L. R. Johnson—from certain citizens of Australia praying that milk substitutes for children up to 6 years of age be restored to the schedule of pharmaceutical benefits.
 - Mr Howard—from certain citizens of Australia praying that the right of all trade union members to participate in ballots be guaranteed, voting in union elections be made compulsory and re-introduction of the collegiate system of union elections be resisted.
 - Mr E. L. Robinson (Minister for Post and Telecommunications)—from certain citizens of Australia praying that further mining and export of uranium, except for bio-medical purposes, be banned and the Australian Atomic Energy Commission be transformed into an Australian Energy Commission.
 - Mr Baillieu—from certain students and staff at Christ College, Vic., praying that the Tertiary Education Assistance Scheme allowance be raised from \$30 to \$48 per week.
 - Mr Carige—from certain electors of the Division of Capricornia praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Chapman—from certain citizens of Australia praying that the mining of uranium in Australia be restricted to that needed for physical and bio-medical research and medical diagnosis,

Mr Connolly—from certain citizens of Australia praying that all current woodchip export licences be cancelled, more funds be provided for research into the recycling of used packaged material and future applications for woodchip leases be preceded by an environmental inquiry.

Mr Connolly—from certain citizens of Australia praying that the Government remove or substantially increase the \$300 limit on income tax deductibility on

personal residential land and water rates.

Mr Hayden—from certain citizens of Australia praying that the Cadet forces be re-instated.

Mr Hurford—from certain citizens of Australia praying that the Australian delegation to the fourth session of UNCTAD be instructed to support the principle of an integrated program of commodities and take certain other action.

Mr L. R. Johnson—from certain citizens of Australia praying that the decision to curtail the home mortgage interest tax deduction scheme be reconsidered and the benefits be upgraded by indexation.

Dr Klugman—from certain citizens of Australia praying that the introduction of television and radio licence fees, the imposition of a tax levy for Medibank and the introduction of higher charges for drugs dispensed under the pharmaceutical benefits scheme be prevented.

Mr McLean—from certain citizens of Australia praying that the means test on all aged pensions be abolished immediately.

Mr Morris—from certain citizens of Australia praying that a system of double income tax on personal incomes be not re-introduced.

Mr Morris—from certain citizens of Newcastle, N.S.W., praying that the Government place immediate orders with the Newcastle State Dockyard and implement the plan to build a graving dock in Newcastle.

11 Message from the Senate—Constitutional Convention—Participation by Commonwealth Parliament: The following message from the Senate was reported:

Mr Speaker,

Message No. 57

The Senate transmits to the House of Representatives the following Resolution which was agreed to by the Senate this day:

That the Senate agrees that the Commonwealth Parliament participate with the Parliaments of the States in the continuing work of the Constitutional Convention established to review the Commonwealth of Australia Constitution, and accordingly resolves:

- (1) That, for the purposes of the Convention—
 - (a) a Delegation from the Commonwealth Parliament consisting of sixteen members of the Parliament take part in the deliberations of the Convention, of whom six shall be members of the Senate and ten shall be members of the House of Representatives;
 - (b) the six members of the Senate comprise two members of the Liberal Party of Australia, one member of the National Country Party of Australia and three members of the Australian Labor Party:
- (2) That-
 - (a) three Senators, two being members of the Liberal Party of Australia and one being a member of the National Country Party of Australia, nominated by the Leader of the Government in the Senate; and
 - (b) three Senators, being members of the Australian Labor Party, nominated by the Leader of the Opposition in the Senate, be members of the Delegation:
- (3) That the Prime Minister be the Leader of the Delegation, and the Leader of the Opposition be the Deputy Leader:
- (4) That a member of the Delegation cease to be such a member if—
 - (a) he ceases to be a member of the Commonwealth Parliament;
 - (b) the House of the Parliament of which he is a member terminates his appointment; or
 - (c) he resigns as a member of the Delegation by writing addressed to the President of the Senate or the Speaker of the House of Representatives, as the case requires:
- (5) That where, because of illness or any other cause, a member of the Delegation is not available to attend a meeting, or part of a meeting, of the Convention, the Leader or senior available member of the Party in the House from which the member was drawn may nominate an alternate member (being a member of the House of which the first-mentioned member is a member) and the member so nominated shall be a member of the Delegation for that meeting, or that part of that meeting:
- (6) That, in the event of a member of the Delegation ceasing to be such a member, the Leader of the Party in the House from which the member was drawn may nominate another member (being a member of the House of which the first-mentioned member is or was a member) to replace the first-mentioned member:
- (7) That the Leader of the Delegation from time to time make a report for presentation to each House of the Parliament on matters arising out of the Convention, and that the Deputy Leader of the Delegation may make an accompanying report.
