TUESDAY, 17 AUGUST 1976

1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.

2 MINISTERIAL AND ADMINISTRATIVE CHANGES AND ARRANGEMENTS: Mr Fraser (Prime Minister) informed the House of the following ministerial and administrative changes and arrangements since the House last met:

On 8 July 1976 His Excellency the Governor-General had determined the appointment of Senator Greenwood as Minister for Environment, Housing and Community Development, accepted the resignation of Mr Newman as Minister for Repatriation and appointed Mr Newman and Senator Durack as Minister for Environment, Housing and Community Development and Minister for Repatriation, respectively.

As a result of these changes, the representation of Ministers would be varied as follows:

In the Senate-

Senator Carrick (Minister for Education) would represent the Minister for Environment, Housing and Community Development.

Senator Durack would represent the Minister for Employment and Industrial Relations, the Attorney-General and the Minister for Business and Consumer Affairs.

In this House Mr Newman would represent the Minister for Repatriation.

Child care matters had been placed under the responsibility of the Minister for Social Security.

Mr Street (Minister for Employment and Industrial Relations) would assist the Prime Minister in Women's Affairs matters and Mr Staley (Minister for the Capital Territory) would assist the Prime Minister in matters concerning the Arts.

During the absence abroad of Mr Anthony (Minister for Overseas Trade and Minister for National Resources), Senator Cotton (Minister for Industry and Commerce) was acting as Minister for Overseas Trade and Mr Nixon (Minister for Transport) was acting as Minister for National Resources. In the House Mr Howard (Minister for Business and Consumer Affairs) would represent the Acting Minister for Overseas Trade.

3 DEATH OF THE RIGHT HONOURABLE LORD CASEY: Mr Fraser (Prime Minister) referred to the death of the Right Honourable Lord Casey, and moved—That this House expresses its deep regret at the death on 17 June 1976 of the Right Honourable Lord Casey, Baron of Berwick, Victoria and of the City of Westminster, England, K.G., P.C., G.C.M.G., C.H., D.S.O., M.C., K.ST.J., a former Governor-General of the Commonwealth of Australia from 1965 to 1969, a Member of this House from 1931 to 1940 and from 1949 to 1960 and Minister of the Crown from 1935 to 1940 and from 1949 to 1960, places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.

And Mr E. G. Whitlam (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Deputy Leader of the National Country Party of Australia), Mr Speaker and other honourable Members having addressed the House in support thereof, and all Members present having risen, in silence—

- 4 DEATHS OF FORMER SENATORS (MR T. L. BULL, MR W. E. AYLETT AND MR G. I. WHITESIDE) AND FORMER MEMBER (MR L. J. FAILES): Mr Fraser (Prime Minister) referred
 to the deaths of Mr T. L. Bull, Mr W. E. Aylett, Mr G. I. Whiteside and Mr L. J.
 Failes, and moved—That this House expresses its deep regret at the deaths of Thomas
 Louis Bull, O.B.E., a former Senator for the State of New South Wales, William
 Edward Aylett, a former Senator for the State of Tasmania, George Irvine Whiteside,
 a former Senator for the State of Queensland, and Laurence John Failes, a former
 Member of this House for the electorate of Lawson, places on record its appreciation
 of their long and meritorious public service and tenders its profound sympathy to
 their families in their bereavement.
 - And Mr E. G. Whitlam (Leader of the Opposition) having seconded the motion, and Mr Sinclair (Deputy Leader of the National Country Party of Australia) and Mr Sullivan having addressed the House in support thereof, and all Members present having risen, in silence—

 Question—passed.
 - 5 Suspension of sitting as MARK of RESPECT: As a mark of respect to the memory of the deceased, the sitting was thereupon suspended until 8 p.m.
- 6 RESUMPTION OF SITTING: At 8 p.m., Mr Speaker resumed the Chair.
- 7 Message from the Governor-General, Proposed expenditure, Appropriation for payment of increases in salaries and wages, and Appropriation for Loan Consolidation and Investment Reserve, for year 1976–77—Appropriation Bill (No. 1) 1976–77—Budget speech: Message No. 66, dated 17 August 1976, from His Excellency the Governor-General was announced:
 - (a) transmitting to the House of Representatives particulars of proposed expenditure from the Consolidated Revenue Fund for the service of the year ending on 30 June 1977, and recommending an appropriation of the Consolidated Revenue Fund accordingly; and
 - (b) further recommending to the House of Representatives an appropriation of the Consolidated Revenue Fund for the service of the year ending on 30 June 1977, for the payment of such increases in salaries and wages and payments in the nature of salary, for which provision is made in the attached particulars of proposed expenditure as have become payable or become payable, or have commenced or commence to be paid, during that year in accordance with any law, or in accordance with an award, order or determination made under a law; and
 - (c) further recommending to the House of Representatives an appropriation of the Consolidated Revenue Fund in respect of the year ending on 30 June 1977, for the purposes of the Loan Consolidation and Investment Reserve established by the Loan Consolidation and Investment Reserve Act 1955, of such sums as the Treasurer from time to time determines.
 - Mr Lynch (Treasurer) presented a Bill for an Act to appropriate certain sums out of the Consolidated Revenue Fund for the service of the year ending on 30 June 1977. Bill read a first time.
 - Mr Lynch moved—That the Bill be now read a second time, and delivered the budget speech.
 - Debate adjourned (Mr E. G. Whitlam—Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.
