 - Mr Beazley, Dr Jenkins and Mr L. K. Johnson—from certain citizens praying that Medibank be maintained.
 - Mr Garrick, Mr Jacobi and Mr Wallis—from certain citizens praying that the previous Government's undertaking on the taxation of moneys due to the Thalidomide Foundation Limited be honoured.
 - Mr J. L. McMahon, Mr Morris and Mr A. P. Whitlam—from certain citizens praying that the independence of the Australian Broadcasting Commission be maintained, advertising on the A.B.C. be rejected, public funding of the Commission be developed and any general inquiries into broadcasting be conducted publicly.
 - Mr Street (Minister for Employment and Industrial Relations) and Mr Baillieu from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.

Whitlam (Leader of the Opposition) informed the House that, during the absence of Mr Nicholls (Opposition Whip), owing to illness, and Mr James (Deputy Opposition Whip), owing to Parliamentary business overseas, Mr L. R. Johnson would act as Opposition Whip and Mr L. K. Johnson as Deputy Opposition Whip.
- 11 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—UNEMPLOYMENT CRISIS: Mr Acting Speaker informed the House that both Mr Willis and Mr Neil had proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr Willis, namely, "The Government's perfunctory response to the unemployment crisis".

Message No. 97

The Senate returns to the House of Representatives the Bill for "An Act to amend the 'Aged Persons Hostels Act 1972–1974'", and acquaints the House that the Senate has agreed to the Bill with the Amendments indicated by the annexed Schedule, in which Amendments the Senate requests the concurrence of the House of Representatives.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

No. 1-Page 2, clause 4, lines 6 to 8, leave out the clause, insert the following clause:

"4. Section 9 of the Principal Act is amended by omitting from sub-section (1) the words 'approval of the hostel under section 5 of this Act' and substituting the words 'the making of the grant or within such further period as the Director-General fixes having regard to the circumstances of a particular case'.".

No. 2-Page 2, after clause 4, insert the following new clause:

"4A. Section 10 of the Principal Act is amended by adding at the period of operation."

- (2) Where---
- (a) an approval under section 5 was given, within the period referred to in sub-section (1), with respect to a building proposed to be erected on a particular site proposed to be acquired by the organization concerned; and
- (b) the Director-General is satisfied that, by reason of exceptional circumstances beyond the control of the organization, the organization has been unable to acquire that site,

the Director-General may, in his discretion, at the request of the organization, vary the approval by substituting a reference to another site for the reference to the first-mentioned site and, thereupon, that approval has effect as so varied.'.".

On the motion of Mr Hunt (Minister representing the Minister for Social Security), the amendments were agreed to.
