WEDNESDAY, 24 AUGUST 1977

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable B. M. Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Bowen, Mr Hurford, Mr McLeay, Mr Neil, Dr Richardson, Mr E. L. Robinson, Mr Ruddock and Mr Sinclair—from certain citizens praying that the Broadcasting and Television Act be amended in relation to program standards.
 - Mr Dobie, Mr Jones, Mr Martin, Mr Neil, Mr Newman and Mr Ruddockfrom certain members of the Australian Association for Better Hearing and others praying that consideration be given to waiving costs for special telephone equipment required by hearing impaired members of the public.
 - Mr Baume, Dr Edwards, Mr Graham and Mr Neil—from certain citizens praying that the decision withdrawing financial assistance from students of non-State tertiary institutions be reversed.
 - Dr Jenkins-from certain students in the same terms as the last preceding petition.
 - Mr Bowen, Mr Dobie, Mr Neil, Mr I. L. Robinson and Mr Sainsbury-from certain citizens praying that private nursing homes be subsidised to allow pensioner patients to retain \$6 per week for personal use and that certain other action be taken in connection with pensioner benefits.
 - Mr Aldred, Mr Groom and Dr Klugman—from certain citizens praying that increases in the Consumer Price Index be applied to pensions and that future pensions not be reduced as a result of any revision of the Index.
 - Mr Sinclair and Mr Yates—from certain citizens praying that steps be taken to end commercial whaling.
 - Mr Falconer—from certain electors of the Division of Casey in the same terms as the last preceding petition.
 - Mr Connolly and Mr I. L. Robinson—from certain citizens praying that the part of a deceased person's estate which passes to the surviving spouse be free from federal estate duty.
 - Mr Anthony—from certain members of the Order of the White Cross praying that action be taken to facilitate the release of Rudolf Hess from prison.
 - Mr Braithwaite—from certain citizens praying that private clinics be prevented from performing abortions in the A.C.T. and that abortions not be financed through Medibank.
 - Mr Brown—from certain citizens praying that whale killing be stopped in 1977 and that Albany whaling station be converted to a research station.
 - Dr J. F. Cairns—from certain citizens praying that rent increases for Defence Forces Married Quarters be reversed and certain other action be taken in connection with service provided married quarters.
