### TUESDAY, 2 MAY 1978

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.

15 COMMONWEALTH BANKS AMENDMENT BILL 1978: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Hurford who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the second reading of this Bill the House is of the opinion that the removal of the existing restrictions on lending by the Commonwealth Development Bank will prove of limited benefit to those entitled to borrow unless additional funds are made available to the Bank".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

On the motion of Mr Howard (Treasurer), by leave, the following new clauses were together added to the Bill:

"4. Section 84 of the Commonwealth Banks Act 1959 is repealed. Repeal

"5. After section 85 of the Commonwealth Banks Act 1959 the following section is inserted:

'85A. (1) The Development Bank shall not, except with the Limitation approval of the Treasurer, borrow moneys other than moneys lent on borrowing to, or deposited with, it under section 85.

'(2) The Treasurer may give an approval for the purposes of subsection (1) in respect of a particular borrowing or in respect of borrowings included in a particular class of borrowings.'.

"6. Section 111 of the Commonwealth Banks Act 1959 is amended Borrowing by omitting from sub-section (3) 'One thousand five hundred dollars' by officers and substituting '\$5,000 or, if another amount is prescribed for the purposes of this sub-section, that other amount'."

Bill, as amended, agreed to.

Bill to be reported with amendments.

The House resumed; Mr Millar reported accordingly.

On the motion of Mr Howard, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

16 PAY-ROLL TAX (TERRITORIES) ASSESSMENT AMENDMENT BILL 1978: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Willis who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the House is of the opinion that the Bill should be withdrawn and redrafted to provide for levels of exemption from pay-roll tax no less than those that will apply in the State of Queensland from 1 July 1978".

Debate continued.

Amendment negatived.
