- 8 AUSTRALIA-PAPUA NEW GUINEA MARITIME BOUNDARIES AND OTHER MATTERS RELATING TO TORRES STRAIT—MINISTERIAL STATEMENT AND PAPERS—MOTION TO TAKE NOTE OF PAPERS: Mr Peacock (Minister for Foreign Affairs), by leave, made a ministerial statement informing the House of the principal basic elements to be included in the treaty to be concluded on maritime boundaries and other matters relating to Torres Strait between Australia and Papua New Guinea and, by command of His Excellency the Governor-General, presented the following papers:

- 9 CONSTITUTIONAL CONVENTION—PARTICIPATION BY COMMONWEALTH PARLIAMENT: Mr Fraser (Prime Minister), pursuant to notice, moved—
 - (1) That the House of Representatives agrees that the Commonwealth Parliament participate with the Parliaments of the States in the continuing work of the Constitutional Convention established to review the Commonwealth of Australia Constitution and accordingly resolves:
 - (a) That, for the purposes of the Convention-
 - (i) a delegation from the Commonwealth Parliament consisting of 16 members of the Parliament take part in the deliberations of the Convention, of whom 6 shall be members of the Senate and 10 shall be members of the House of Representatives;
 - (ii) the 10 members of the House of Representatives comprise 3 members of the Liberal Party of Australia, 2 members of the National Country Party of Australia and 5 members of the Australian Labor Party:
 - (b) That---
 - (i) the Prime Minister and 4 other members of the House of Representatives, 2 being members of the Liberal Party of Australia and 2 being members of the National Country Party of Australia, nominated by him; and
 - (ii) the Leader of the Opposition and 4 other members of that House, being members of the Australian Labor Party, nominated by him, be members of the Delegation:
 - (c) That the Prime Minister be the Leader of the Delegation, and the Leader of the Opposition be the Deputy Leader:
 - (d) That a member of the Delegation cease to be such a member if-
 - (i) he ceases to be a member of the Commonwealth Parliament;

- (ii) the House of the Parliament of which he is a member terminates his appointment; or
- (iii) he resigns as a member of the Delegation by writing addressed to the President of the Senate or the Speaker of the House of Representatives, as the case requires:
- (e) That where, because of illness or any other cause, a member of the Delegation is not available to attend a meeting, or part of a meeting, of the Convention, the Leader or senior available member of the Party in the House from which the member was drawn may nominate an alternate member (being a member of the House of which the first-mentioned member is a member) and the member so nominated shall be a member of the Delegation for that meeting, or that part of that meeting:
- (f) That, in the event of a member of the Delegation ceasing to be such a member, the Leader of the Party in the House from which the member was drawn may nominate another member (being a member of the House of which the first-mentioned member is or was a member) to replace the first-mentioned member:
- (g) That the Leader of the Delegation from time to time make a report for presentation to each House of the Parliament on matters arising out of the Convention, and that the Deputy Leader of the Delegation may make an accompanying report.
- (2) That a message be sent to the Senate acquainting it of the resolution agreed to by the House of Representatives.

Debate ensued.

Question-put and passed.

10 TRADE UNION TRAINING AUTHORITY AMENDMENT BILL 1978: Mr Street (Minister for Employment and Industrial Relations), pursuant to notice, presented a Bill for an Act to amend the *Trade Union Training Authority Act* 1975.

Bill read a first time.

Mr Street moved-That the Bill be now read a second time.

- Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.
- 11 LOAN AMENDMENT BILL 1978: Mr Garland (Minister for Special Trade Representations), for Mr Howard (Treasurer), pursuant to notice, presented a Bill for an Act to amend the Loan Act 1977.

Bill read a first time.

Mr Garland moved-That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

Bill read a first time.

Mr Garland moved-That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

13 SALES TAX (EXEMPTIONS AND CLASSIFICATIONS) AMENDMENT BILL 1978: Mr Garland (Minister for Special Trade Representations) presented a Bill for an Act to amend the Sales Tax (Exemptions and Classifications) Act 1935, and for related purposes. Bill read a first time.

Mr Garland moved-That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

14 OMBUDSMAN AMENDMENT BILL 1978: Mr Garland (Minister for Special Trade Representations), for Mr Viner (Minister Assisting the Prime Minister), pursuant to notice, presented a Bill for an Act to amend the *Ombudsman Act* 1976 for purposes related to the self-government of the Northern Territory, and for purposes incidental thereto. Bill read a first time.

Mr Garland moved--That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

- 15 CUSTOMS TARIFF VALIDATION BILL 1978: Mr Fife (Minister for Business and Consumer Affairs) presented a Bill for an Act to provide for the validation of certain collections of duties of Customs.
 - Bill read a first time.
 - Mr Fife moved—That the Bill be now read a second time.

Debate adjourned (Mr Willis), and the resumption of the debate made an order of the day for the next sitting.

16 DEFENCE SERVICE HOMES AMENDMENT BILL 1978: Mr Garland (Minister for Veterans' Affairs), pursuant to notice, presented a Bill for an Act to amend the *Defence Service Homes Act* 1918.

Bill read a first time.

Mr Garland moved---That the Bill be now read a second time.

- Debate adjourned (Mr Uren), and the resumption of the debate made an order of the day for the next sitting.
- 17 FISHERIES AMENDMENT BILL 1978: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— And on the amendment moved thereto by Mr Bowen (Deputy Leader of the Opposition), viz.—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House calls upon the Government to ensure that the guidelines determined by the Australian Fisheries Council in January 1977, to control foreign participation and give first priority to the local industry, are strictly observed"—

Debate resumed.

Amendment amended by Mr Bowen, by leave, by omitting "1977" from the words proposed to be substituted and substituting "1978".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

- 18 CONTINENTAL SHELF (LIVING NATURAL RESOURCES) AMENDMENT BILL 1978: The order of the day having been read for the resumption of the debate on the question— That the Bill be now read a second time—

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

Amendment negatived.

Mr Viner (Minister for Aboriginal Affairs) moved—That the Bill be now read a third time.

Question—put and passed—Bill read a third time.

20 AUSTRALIAN SCIENCE AND TECHNOLOGY COUNCIL BILL 1978: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question-put and passed-Bill read a second time.

The House resolved itself into a committee of the whole.

In the committee

Bill, by leave, taken as a whole.

Dr Klugman, by leave, moved the following amendments together:

Clause 5, page 2, omit the clause, substitute the following clause:

"5. The functions of the Council are to investigate, and to furnish Functions information and advice to the Commonwealth Government in respect of, matters relating to science and technology, including the following matters:

- (a) the advancement of scientific knowledge;
- (b) the implications for the community, for the environment, for industry and for Government policy of developments in science and technology;
- (c) utilising science and technology in the development of national objectives;
- (d) priorities for scientific and technological research and development, and on policies to give best effect to these priorities;
- (e) the organisation of and institutional arrangements for the conduct of scientific and technological activities;
- (f) manpower policies for science and technology;
- (g) the fostering of scientific and technological innovation in industry; and
- (h) utilising science and technology in the achievement of national objectives.".

Clause 6, page 3, after sub-clause (3) add the following sub-clauses:

"(4) Where the Minister exercises his discretion in favour of causing the report to be laid before the Parliament with deletions he shall disclose to Parliament the grounds upon which such deletions were made.

"(5) Where the Minister exercises his discretion in favour of causing the report not to be laid before the Parliament he shall within 15 sitting days after receiving the report disclose to Parliament that he has received the report and the grounds upon which he has exercised such discretion.".

Clause 8, page 3, omit sub-clause (1), substitute the following sub-clause:

"(1) The Council shall perform its functions and exercise its powers as it sees fit and shall act upon any directions given to it by the Minister in writing.".

Clause 10, page 4, omit sub-clause (1), substitute the following sub-clause:

"(1) The Council shall consist of a Chairman, a Deputy Chairman and not less than 7, nor more than 15, ordinary members of whom at least 2 shall be persons professionally qualified as social scientists, 3 shall be scientists currently involved in research and 2 shall be members of the Australian Parliament appointed respectively by the Prime Minister and the Leader of the Opposition.". Clause 11— Page 4, lines 26 and 27, omit ", but is eligible for re-appointment". Page 4, omit sub-clause (2). Page 4, omit sub-clause (3). Page 4, omit sub-clause (4). Page 4, omit sub-clause (5). Page 5, omit sub-clause (6). Page 5, omit sub-clause (8). Debate continued. Amendments negatived. Bill agreed to.

Bill to be reported without amendment.

The House resumed; Mr Millar reported accordingly.

On the motion of Mr Viner (Minister Assisting the Prime Minister), the House adopted the report.

Mr Viner, by leave, moved—That the Bill be now read a third time.

Debate ensued.

Question-put and passed-Bill read a third time.
