TUESDAY, 19 SEPTEMBER 1978

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DISTINGUISHED VISITORS: Mr Speaker informed the House that members of the Public Accounts Committee of the Solomon Islands National Parliament, led by Mr P. Kapini, M.P., were present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a warm welcome.
- 3 Pertitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Ellicott, Mr Howard, Mr Neil and Mr Sinclair—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Goodluck, Mr Lusher and Sir William McMahon—from certain members of the Sydney University Post Graduate Representative Association and others, praying that Commonwealth postgraduate research awards be adjusted annually in line with the consumer price index and not be taxed.
 - Mr Bryant—from certain citizens praying for the establishment of a fund whereby loans can be made to means tested pensioners for the necessary maintenance of their homes.
 - Mr Cairns—from certain citizens praying that the family allowance not be reduced or means tested.
 - Mr Ellicott—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Fraser—from certain citizens praying that lone fathers receive a pension on the same basis as supporting mothers.
 - Mr Viner—from certain citizens praying that Government benefits under Schedule 6469 not be removed.
