TUESDAY, 14 NOVEMBER 1978

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Privilege: Mr Bowen (Deputy Leader of the Opposition) referred to the declaration relating to Crown privilege made by the High Court in the case of Sankey v. Whitlam and others (9 November 1978) and the possible application of the principle as declared by the Court to the production of Ministerial documents in the House when required by any Member, Mr Speaker being the judge of confidentiality.
 - Mr Speaker stated that he would examine the matter and report to the House.
- 3 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr J. J. Brown, Mr Dobie, Mr Lucock, Sir William McMahon, Mr Martyr, Mr Scholes, Mr Shack, Mr Stewart and Mr Viner—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Aldred, Mr N. A. Brown, Mr Hunt and Mr Lynch—from certain citizens praying that the Medical Benefits Schedule be amended to preclude payment of benefits for abortions.
 - Mr Baume—from certain residents of the Electoral Division of Macarthur praying that support be given to the general business motion of the honourable Member for Hume concerning medical benefits for abortion.
 - Mr Lusher—from certain residents of the Electoral Division of Werriwa in the same terms as the last preceding petition.
 - Mr Lucock and Sir William McMahon—from certain citizens praying that no measures be taken to implement those recommendations of the Royal Commission on Human Relationships that will further undermine and weaken marriage, child-care or the family.
 - Mr Bradfield—from certain citizens praying that the former post office building in Kogarah, N.S.W., be given to the people of Kogarah as a women's rest centre and community aid centre.
 - Mr E. C. Cameron—from certain electors of the Electoral Division of Indi praying that land not necessary for development by the Albury-Wodonga Development Corporation be released from compulsory acquisition.
 - Mr Goodluck—from certain citizens praying that the imperial system of weights and measures be restored.
 - Mr L. R. Johnson—from certain citizens praying that Kingsford-Smith Airport, Sydney, not be extended and that no related decisions be taken without consultation with affected communities.
 - Mr L. R. Johnson—from certain citizens praying that indirect tax measures, such as a Retail Turnover Tax or a Value Added Tax, not be introduced.

- Mr C. K. Jones—from certain citizens praying that proposed changes to Medibank not be implemented and that there be consultation with the trade unions and the community.
- Mr Morris—from certain citizens praying for the replacement of the 1978-79 Budget by a budget which increases the level of economic activity, lowers unemployment, assists the disadvantaged and revives business and consumer confidence.
- Mr Porter—from certain citizens praying for continued and increased Federal subsidies to maintain all existing South Australian country rail services.
- Mr Sinclair—from certain citizens praying for a halt in the automation of rural telephone exhanges pending a Parliamentary inquiry.
- Mr Uren—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.

- 4 MINISTERIAL ARRANGEMENTS: Mr Fraser (Prime Minister) informed the House that, during the absence abroad of Mr Garland (Minister for Special Trade Representations and Acting Minister for Veterans' Affairs), Mr Anthony (Minister for Trade and Resources) was acting as Minister for Special Trade Representations and Mr McLeay (Minister for Construction) was acting as Minister for Veterans' Affairs and was representing the Minister for Science in this House.
- 5 Suspension of standing orders—Motion of censure of Prime Minister: Mr Hayden (Leader of the Opposition) having given a notice of motion—
 - Mr Sinclair (Leader of the House), by leave, moved—That so much of the standing orders be suspended as would prevent the Leader of the Opposition moving forthwith the motion of censure of the Prime Minister of which he has given notice for the next sitting.

Question—put and passed.

- 6 PRIME MINISTER—MOTION OF CENSURE: Mr Hayden (Leader of the Opposition) moved— That this House censures the Prime Minister because—
 - (1) in matters concerning the Minister for Primary Industry, the Prime Minister has failed to adhere to principles and practice he has stated and followed in the past requiring Ministers to stand down when they are subject to investigation in regard to matters that raise questions about the propriety of their conduct and
 - (2) this failure has led to allegations and disclosures which tend to reflect discredit onto the Parliament as a whole, and not merely on the Government, the Prime Minister and the Minister for Primary Industry.

Mr Hayden asked leave to present certain papers.

Objection being raised, leave not granted.

Mr Young moved—That Mr Hayden be granted an extension of time.

Question-put and negatived.
