TUESDAY, 3 APRIL 1979

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Burns, Mr Fraser, Mr Kerin, Mr Lynch, Mr Martin, Mr Morris, Mr Short and Mr Sinclair—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Aldred—from certain citizens praying that the taxation law be amended to permit registered tax agents to trade for a full year and lodge income tax returns at the close of the respective tax year.
 - Mr Burr—from certain citizens praying that the medical benefits schedule be amended to preclude payment of benefits for any abortion except one performed when the mother's life is endangered.
 - Mr Cairns—from certain citizens praying that item 6469 be removed from the standard medical benefits table.
 - Mr Dobie—from certain citizens praying for the prohibition of pornographic material involving children.
 - Dr Edwards—from certain citizens praying for the establishment of a fund whereby loans can be made to means tested pensioners for the necessary maintenance of their homes.
 - Dr Everingham—from certain citizens praying that action be taken to improve the retirement conditions of all sections of the Australian workforce that are not supported by superannuation or long service leave schemes.
 - Mr Hodges—from certain citizens praying that pensions be increased twice-yearly in line with rises in the consumer price index.
 - Mr Howe—from certain citizens praying that the decision to suspend reconstruction aid to, and cultural exchanges with, the Socialist Republic of Vietnam be reversed.
 - Mr L. R. Johnson—from certain citizens praying that Kingsford-Smith Airport, Sydney, not be extended and that no related decisions be taken without consultation with affected communities.
 - Mr Killen—from certain citizens praying that legislation be introduced to prevent payment of medical benefits for unnecessary abortions.
 - Mr Killen—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.
 - Dr Klugman—from certain electors of New South Wales praying that compensation benefits paid to injured Commonwealth Government employees be increased and then adjusted automatically.
 - Mr Lynch—from certain electors of the Electoral Division of Flinders praying that pensions be adjusted at 6 monthly intervals.

Mr J. L. McMahon—from certain citizens praying that a site for Sydney's second airport be selected immediately.

Mr Moore—from certain electors of the Electoral Division of Ryan praying that legislation be introduced to protect the Great Barrier Reef from mining and that the Reef and surrounding waters be declared a national marine park.

- 12 INDUSTRIAL DISPUTATION—MINISTERIAL STATEMENT—PAPER NOTED: Mr Street (Minister for Industrial Relations), by leave, made a ministerial statement informing the House of specific decisions taken by the Government in response to current industrial disputation, and, by command of His Excellency the Governor-General, presented the following paper:
 - Industrial disputation-Ministerial statement, 3 April 1979.
 - Mr McLeay (Minister for Administrative Services) moved—That the House take note of the paper.
 - Debate ensued.

- 13 HIGH COURT JUSTICES (LONG LEAVE PAYMENTS) BILL 1979: Mr Viner (Minister representing the Attorney-General), pursuant to notice, presented a Bill for an Act to make provision for payments, in lieu of long leave, on the retirement or death of Justices of the High Court.
 - Bill read a first time.

Mr Viner moved-That the Bill be now read a second time.

Debate adjourned (Mr Bowen—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

14 JUDGES (LONG LEAVE PAYMENTS) BILL 1979: Mr Viner (Minister representing the Attorney-General), pursuant to notice, presented a Bill for an Act to make provision for payments, in lieu of long leave, on the retirement or death of certain Judges (other than Justices of the High Court) and persons having the Status of Judges. Bill read a first time.

Mr Viner moved—That the Bill be now read a second time.

Debate adjourned (Mr Bowen—Deputy Leader of the Opposition), and the resumption of the debate made an order of the day for the next sitting.

- 15 NATIONAL RAILWAY NETWORK (FINANCIAL ASSISTANCE) BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Morris who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that—
 - (1) the provision of financial assistance by section 96 interest bearing repayable grants is a repudiation of the Government's 1977 Election promise to contribute to the cost of upgrading mainline rail links in the light of the clear impression then given that assistance would be by way of non-repayable grants, and
 - (2) the provision of \$3 million to the States for 1978-79 under this Bill (a) is abysmally inadequate and an abrogation of Australian Government responsibility for the transportation of passengers and freight on routes of national significance, and (b) is wholly inconsistent with an effective approach to the upgrading of mainline railway networks as an essential part of a responsible National Energy Conservation Program".
