- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (THE RIGHT HONOURABLE SIR CHARLES ADERMANN): Mr Anthony (Acting Prime Minister) referred to the death of the Right Honourable Sir Charles Adermann, and moved—That this House expresses its deep regret at the death, on 9 May 1979, of the Right Honourable Sir Charles Frederick Adermann, K.B.E., a Member of this House for the Division of Maranoa from 1943 to 1949 and for the Division of Fisher from 1949 to 1972, Chairman of Committees from 1950 to 1958 and a Minister of the Crown from 1958 to 1967; and that this House places on record its appreciation of his long and meritorious public service and tenders its profound sympathy to his widow and family in their bereavement.
 - And Mr Hayden (Leader of the Opposition) having seconded the motion, and Mr Lynch (Deputy Leader of the Liberal Party of Australia), Mr Speaker and other Members having addressed the House in support thereof, and all Members present having risen, in silence—

Question-passed.

- 3 DISTINGUISHED VISITORS: Mr Speaker informed the House that the Honourable Yitzhak Shamir, Speaker of the Knesset of Israel, was within the precincts. With the concurrence of Members, the distinguished visitor was provided with a seat on the floor of the House.
 - Mr Speaker then informed the House that Mr Shamir was leader of a delegation from the Knesset of Israel and that members of the delegation were present in the gallery. On behalf of the House, Mr Speaker extended to the visitors a warm welcome.
- 4 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Bradfield, Mr Burns, Dr Edwards, Mr Falconer, Mr Holding, Mr Johnston, Mr C. K. Jones, Mr Lusher, Mr Lynch, Mr Martin, Mr Morris, Mr O'Keefe and Mr Scholes—from certain citizens praying that pension payments be restored to twice-yearly adjustments and that pensions and unemployment benefits be raised to 30% of average weekly earnings.
 - Mr Braithwaite, Mr N. A. Brown, Mr Haslem and Mr Yates—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
 - Mr Dobie and Dr Klugman—from certain citizens praying for the appointment of an independent inquiry into the Australian Broadcasting Commission to investigate the qualifications of commissioners and certain other matters.
 - Mr Scholes and Mr Willis—from certain citizens praying for the resignation of Members who have not honoured an election undertaking to retain twice-yearly adjustments of social security pensions in accordance with movements in the consumer price index.
 - Mr Adermann—from certain citizens praying that handcrafted articles be exempted from sales tax and certain other action be taken in relation to the Sales Tax (Exemptions and Classifications) Act.

Mr Bradfield—from certain citizens praying for the prohibition of pornographic material involving children.

Mr Cairns—from certain citizens praying that the importation of whale products be banned.

Mr Hodges—from certain citizens praying that pensions be increased twice yearly in line with rises in the consumer price index.

Mr Lusher—from certain citizens praying that an assistance benefit for single parent fathers be introduced.

Mr J. L. McMahon—from certain residents of Newtown, N.S.W., praying that the proposal of the Major Airport Needs of Sydney Study to construct a new runway at Kingsford-Smith Airport be rejected.

- 9 Customs Amendment Bill 1979—Legislation committee: Mr Speaker informed the House that Mr Shipton had been discharged from the legislation committee considering the Customs Amendment Bill 1979 and that Mr D. M. Cameron had been nominated in his place.
- 10 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—BROADCASTING: Mr Speaker informed the House that Mr Hayden (Leader of the Opposition) had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The Government's failure to honour promises, protect the public interest and maintain a coherent set of policies in the field of broadcasting".

The proposed discussion having received the necessary support—

Mr Hayden addressed the House.

Discussion ensued.

Discussion concluded.

11 Customs Amendment Bill 1979—Legislation committee: Mr Peacock (Minister for Foreign Affairs), for Mr Sinclair (Leader of the House), pursuant to notice, moved—
That the legislation committee to consider the Customs Amendment Bill 1979 have power to meet during the sitting of the House on Wednesday, 9 May 1979.

Question—put and passed.

- 12 BOUNTY (ROTARY CULTIVATORS) BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—And on the amendment moved thereto by Mr Hurford, viz.—That all words after "That" be omitted with a view to substituting the following words: "the House declines to give the Bill a second reading until the Government gives the House a satisfactory explanation, inter alia, as to—
 - (a) why the Government considered that the level of short-term assistance on the production and sale in Australia of pedestrian operated rotary cultivators which was recommended by the Industries Assistance Commission might not be adequate;
 - (b) why the House was not informed that the Government had rejected the recommendations of the Commission relating to this matter; and
 - (c) why the Minister in his second reading speech did not explain the reasons for deciding on a bounty which is double the rate recommended by the Commission"—

Debate resumed.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 144, dated 5 April 1979, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

- 13 Atomic Energy Amendment Bill 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Keating who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the House declines to give the Bill a second reading as it is of opinion that—
 - (1) the Australian Atomic Energy Commission should not be empowered to raise funds on the commercial market for uranium mining until such time as the unresolved problems associated with the nuclear industry have been satisfactorily resolved; and
 - (2) the Atomic Energy Act is an inappropriate legislative basis for nuclear energy research and development and for commercial activities and should be repealed and replaced by legislation to establish—
 - (a) an independent regulatory authority responsible for nuclear-related environmental protection, health, safety, security, safeguards and other nonproliferation activities;
 - (b) a government corporation to conduct the present commercial activities of the Australian Atomic Energy Commission, such as the production and marketing of radioisotopes; and
 - (c) a Nuclear Science Authority to perform, as appropriate, the other functions currently undertaken by the Commission".
