SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

No. 1—Page 2, clause 2, sub-clause (5), lines 16 and 17, leave out ", sub-sections 104 (3), (4) and (5) and section 106", insert "and sub-sections 104 (3), (4) and (5)".

No. 2-Page 33, clause 65, sub-clause (2), line 35, leave out "and".

No. 3—Page 33, clause 65, sub-clause (2), line 35, after paragraph (a) of the sub-section proposed to be substituted for sub-section (1) of proposed section 336, insert the following paragraph:

"(aa) the conversion of amounts of money expressed in the franc mentioned in Article 3 of the Convention into amounts of money expressed in the currency of Australia;

No. 4—Page 45, clause 91, proposed section 427, leave out the proposed section, insert the following section:

"427. (1) In this section—

'Code' means the code known as the Uniform Shipping Laws Code Minister adopted by the Council;

'Council' means the conference of Commonwealth and State Laws Code Ministers known as the Marine and Ports Council of Australia.

"(2) The Minister may, by order published in the Gazette, declare—

(a) that the provisions annexed to the order are provisions, or are the provisions, of the Code as in existence on a specified date; or

- (b) that specified provisions of the Code as in existence on a specified date have been varied by the Council on a specified date and that the variations annexed to the order are the variations so made by the Council.
- "(3) An order under sub-section (2) is, for all purposes, *prima facie* evidence of the matters declared in the order.".

On the motion of Mr Nixon (Minister for Transport) the amendments were agreed to, after debate.
