- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

- Dr Cass and Mr Howe—from certain citizens praying that Government proposals to sell publicly owned enterprises be rejected.
- Mr D. M. Cameron—from certain residents of Queensland praying that extra funds be provided to the Noah's Ark Toy Library for handicapped children, New Farm, Qld.
- Mr Falconer—from certain citizens praying that the Post Office at Tunstall Square Shopping Centre, East Doncaster, Vic., be retained.
- Mr Falconer—from certain citizens praying that efforts be made to ensure a general and complete disarmament under effective international control, that the Pacific and Indian Oceans be declared as nuclear-free zones and that all nuclear bases be disbanded.

23 QUEENSLAND GRANT (SPECIAL ASSISTANCE) BILL 1979: Mr Howard (Treasurer), pursuant to notice, presented a Bill for an Act to grant financial assistance to Queensland. Bill read a first time.

Mr Howard moved—That the Bill be now read a second time.

Debate adjourned (Dr Cass), and the resumption of the debate made an order of the day for the next sitting.

    - (1) twice yearly indexation of benefits for the unemployed without dependants;
    - (2) an increase in unemployment benefits for those under 18 years;
    - (3) removal of the provisions relating to the mandatory postponement period for the 'voluntary' unemployed and those who fail the work test;
    - (4) removal of the provision of refusing unemployment and special benefit to those unemployed through the industrial action of others;
    - (5) the updating of supplementary allowances and allowances for pensioners' children to compensate for inflation, and

(6) an increase in family allowances to compensate for their erosion by inflation". Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

*Message from the Governor-General:* Message No. 186, dated 11 October 1979, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.
