## TUESDAY, 6 NOVEMBER 1979

- 1 The House met, at 3 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 DEATH OF FORMER MEMBER (SIR WILLIAM BRAND): Mr Speaker informed the House of the death, on 26 October 1979, of Sir William Brand, C.B.E., a Member of this House for the Division of Wide Bay from 1954 to 1958.
  - As a mark of respect to the memory of the deceased all Members present stood, in silence.
- 3 DEATH OF THE PRESIDENT OF THE REPUBLIC OF KOREA (PARK CHUNG HEE): Mr Anthony (Deputy Prime Minister) referred to the death, on 26 October 1979, of His Excellency Park Chung Hee, President of the Republic of Korea, and paid tribute to the memory of the late President.
  - Mr Hayden (Leader of the Opposition) and Mr Bryant supported the remarks of the Deputy Prime Minister.
  - As a mark of respect to the memory of the deceased all Members present stood, in silence.
