8 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—COAL INDUSTRY: Mr Speaker informed the House that Mr Keating had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The rapid and alarming penetration into the Australian coal industry by the international oil majors and other foreign institutions, and the continuing alienation of Australia's sovereignty over its coal trade".

The proposed discussion having received the necessary support—

Mr Keating addressed the House.

Discussion ensued.

Discussion concluded.

9 INCOME TAX-TRUSTS AND DEPENDENT CHILDREN-MINISTERIAL STATEMENT-PAPER NOTED: Mr Howard (Treasurer), by leave, made a ministerial statement informing the House of proposed modifications to the provisions for taxation of income of trusts and dependent children, and, by command of His Excellency the Governor-General, presented the following paper:

Income tax-Trusts and dependent children-Ministerial statement, 14 November . 1979.

Mr Peacock (Minister for Foreign Affairs) moved—That the House take note of the paper.

Debate ensued.

Question-put and passed.

10 SUGAR AGREEMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Ellicott (Minister for Home Affairs), the Bill was read a third time.

11 STATES GRANTS (SCHOOLS ASSISTANCE) BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Dr Cass who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of opinion that the Government should be condemned for (a) the continuing decline in funding of Australian schools by its failure to honour its firm undertaking to provide for a minimum growth rate of 2% per annum in real terms for schools and (b) its failure to respond to glaring deficiencies and developing needs in the education system highlighted in reports to the Government by its advisory bodies".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 207, dated 25 October 1979, from His Excellency the Governor-General was announced recommending an appropriation of revenue and moneys for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr E. L. Robinson (Minister for Finance), the Bill was read a third time.

12 STATES GRANTS (TERTIARY EDUCATION ASSISTANCE) AMENDMENT BILL (No. 2) 1979: The order of the day having been read for the resumption of the debate on the question—
That the Bill be now read a second time—

Debate resumed by Dr Cass who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of opinion that the Government should be condemned for the (a) continuing decline in funding in real terms for tertiary education in Australia and the consequent long-term detrimental effects on the quality and standard of tertiary institutions and (b) continuing pressure being placed on State Governments to share the cost of tertiary education".

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 208, dated 6 November 1979, from His Excellency the Governor-General was announced recommending an appropriation of revenue and moneys for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

Mr E. L. Robinson (Minister for Finance) moved—That the Bill be now read a third time.

Debate ensued.

Question-put and passed-Bill read a third time.

13 PARLIAMENTARY CONTRIBUTORY SUPERANNUATION AMENDMENT BILL 1979: Mr E. L. Robinson (Minister for Finance), by leave, presented a Bill for an Act to amend the Parliamentary Contributory Superannuation Act 1948.

Bill read a first time.

Mr E. L. Robinson moved-That the Bill be now read a second time.

Debate, by leave, ensued.

Question—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 209, dated 14 November 1979, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr E. L. Robinson, the Bill was read a third time.

14 Snowy Mountains Hydro-electric Power Amendment Bill 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Howard (Treasurer), the Bill was read a third time.

15 WHEAT MARKETING BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Mr Kerin addressing the House-

19 WHEAT PRODUCTS EXPORT ADJUSTMENT AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Groom (Minister for Housing and Construction), the Bill was read a third time.

20 WHEAT TAX BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Groom (Minister for Housing and Construction), the Bill was read a third time.

21 WHEAT RESEARCH AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Groom (Minister for Housing and Construction), the Bill was read a third time.

22 ADJOURNMENT: Mr Groom (Minister for Housing and Construction) moved—That the House do now adjourn.
