'(6A) Where, in proceedings in a court in respect of an offence, objection is taken to the admission of evidence on the ground that the evidence was obtained in contravention of, or in consequence of a contravention of, or in consequence of a failure to comply with a provision of this Act, in relation to a person, the court shall not admit the evidence unless it is, on the balance of probabilities, satisfied that admission of the evidence would specifically and substantially benefit the public interest without unduly prejudicing the rights and freedoms of any person.

'(6B) The matters that a court may have regard to in deciding whether, in proceedings in respect of an offence, it is satisfied as required by sub-

section (6A), include—

(a) the seriousness of the offence in the course of the investigation of which the provision was contravened, or was not complied with, the urgency and difficulty of detecting the offender and the urgency of the need to preserve evidence of the fact;

(b) the nature and seriousness of the contravention or failure; and

(c) the extent to which the evidence that was obtained in contravention of, in consequence of the contravention of, or in consequence of the failure to comply with, the provision might have been lawfully obtained.

'(6c) The burden of satisfying the court that evidence obtained in contravention of, in consequence of the contravention of, or in proceedings of failure to comply with, a provision of this Act should be admitted in proceedings lies on the party who seeks to have the evidence admitted.

'(6D) This section is in addition to, and not in derogation of, any other law or rule under which a court may refuse to admit evidence in proceedings.'.".
