- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

 - Mr Bowen, Mr Connolly and Sir William McMahon—from certain residents of New South Wales praying that the 1980 level of education expenditure to Government schools be restored and increased in real terms.
 - Mr E. C. Cameron, Mr Jarman and Mr Peacock—from certain citizens praying that the National Women's Advisory Council and its recommendations be supported.
 - Mr Cadman and Mr Connolly—from certain citizens praying for the prohibition of pornographic material involving children.
 - Mr Cadman and Mr Jarman—from certain citizens praying that a humane policy be adopted to assist refugees to enter Australia.
 - Mr Connolly and Dr Edwards—from certain citizens praying that the National Women's Advisory Council be maintained and Federal Government support for its activities be increased.
 - Dr Everingham and Mr West—from certain citizens praying that the proposal to increase the marine radio licence fee be reconsidered.

10 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—ECONOMIC STAGFLATION: Mr Deputy Speaker informed the House that Mr Willis had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The intensification of stagflation in the Australian economy resulting from Government policies".

The proposed discussion having received the necessary support— Mr Willis addressed the House.

11 ELECTORAL DIVISIONS OF WESTERN AUSTRALIA—PROPOSED REDISTRIBUTION: Mr Ellicott (Minister for Home Affairs), for Mr J. E. McLeay (Minister for Administrative Services), pursuant to notice, moved—That the House of Representatives approves of the redistribution of the State of Western Australia into Electoral Divisions as proposed by Messrs B. S. Nicholls, J. F. Morgan and F. W. Statham, the Commissioners appointed for the purpose of redistributing the said State into Divisions, in their Report laid before the House of Representatives on 13 November 1979, and that the names of the Divisions suggested in the Report, and indicated in the map referred to therein, be adopted, except that the name of the Division suggested by the Commissioners for identification purposes to be named Canning be named O'Connor and that the name of the Division suggested to be named Roe be named Canning. Debate ensued.

Question-put and passed.

- 13 PIPELINE CONSTRUCTION (YOUNG TO WAGGA WAGGA) BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed.

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Killen (Minister for Defence), the Bill was read a third time.

- 14 ABORIGINAL LAND RIGHTS (NORTHERN TERRITORY) AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question— That the Bill be now read a second time—
 - Debate resumed by Dr Everingham who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House is of the opinion that the Government as soon as possible should extend by legislation the rights of Aborigines in the Northern Territory to Aborigines in the Australian Capital Territory".

Debate continued.

Amendment negatived.

Question-That the Bill be now read a second time-put and passed-Bill read a second time.

The House resolved itself into a committee of the whole.

Bill to be reported without amendment.

15 AUSTRALIAN CAPITAL TERRITORY—JOINT COMMITTEE—REPORT ON PLANNING IN THE A.C.T.—GOVERNMENT RESPONSE—MINISTERIAL STATEMENT—PAPER NOTED: Mr Ellicott (Minister for the Capital Territory), by leave, made a ministerial statement informing the House of the Government's response to the report of the Joint Committee on the Australian Capital Territory on planning in the A.C.T., and, by command of His Excellency the Governor-General, presented the following paper:

Mr Peacock (Minister for Foreign Affairs) moved—That the House take note of the paper.

Debate ensued.

Question—put and passed.

- 16 CUSTOMS TARIFF (COAL EXPORT DUTY) AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Keating who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the House declines to give the Bill a second reading as it is of the opinion that the existing coal export levies are indiscriminate and unworkable and their variations have resulted in a lower level of receipts from highly profitable coal ventures than would have been the case had a profits related taxing mechanism been established, and therefore calls upon the Government to introduce legislation to abolish the coal levies and replace the same with a resource rent tax which takes into account the real level of costs and profit".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

Mr Fife (Minister for Business and Consumer Affairs) moved—That the Bill be now read a third time.

Debate ensued.

Question-put and passed-Bill read a third time.

17 CUSTOMS AMENDMENT BILL (No. 3) 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—Question—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Fife (Minister for Business and Consumer Affairs), the Bill was read a third time.

- 18 CUSTOMS TARIFF VALIDATION BILL (No. 2) 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Hurford who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House is of the opinion that a Parliamentary Standing Committee on Tariffs and Excise should be established to examine each change in tariffs and excise following the gazettal of proposals or their being introduced into the Parliament on the one hand and before related Bills are introduced into the House on the other hand".

Debate continued.

Amendment negatived.

- Question—That the Bill be now read a second time—put and passed—Bill read a second time.
- Leave granted for third reading to be moved forthwith.

Mr Fife (Minister for Business and Consumer Affairs) moved—That the Bill be now read a third time.

Debate ensued.

Question-put and passed-Bill read a third time.

- 19 ADJOURNMENT NEGATIVED: It being 10.30 p.m.—The question was proposed—That the House do now adjourn.
 - Mr Fife (Minister for Business and Consumer Affairs) requiring the question to be put forthwith without debate—

Question-put and negatived.

20 EXCISE TARIFF VALIDATION BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time— Debate resumed by Mr Keating who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and redrafted to exclude the validation of the collection of any increase in excise duty on stabilised crude petroleum oil".

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

Mr Fife (Minister for Business and Consumer Affairs) moved—That the Bill be now read a third time.

Debate ensued.

Question-put and passed-Bill read a third time.

21 ADMINISTRATIVE APPEALS TRIBUNAL AMENDMENT BILL 1979: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
Debate resumpted

Debate resumed,

Question-put and passed-Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Staley (Minister for Post and Telecommunications), the Bill was read a third time.

22 ADJOURNMENT: Mr Staley (Minister for Post and Telecommunications) moved—That the House do now adjourn.

Debate ensued.

The House continuing to sit until 11 p.m.—Mr Deputy Speaker adjourned the House until tomorrow at 10.30 a.m.
