- 7 EUROPEAN PARLIAMENT—PRESENTATION OF GAVEL—STATEMENT BY MR SPEAKER: Mr Speaker made a statement informing the House that on 14 January 1980 he had presented a gavel to the European Parliament on behalf of the Commonwealth Parliament and had extended an invitation to the European Parliament to send a delegation to Australia in 1980.
- 8 Suspension of standing orders—Discussion of matter of public importance: Mr Viner (Leader of the House), by leave, moved—That so much of the standing orders be suspended as would prevent a definite matter of public importance proposed to the Speaker by the honourable Member for Adelaide being submitted to the House for discussion before general business is called on.

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—MOTOR VEHICLE INDUSTRY: Mr Speaker informed the House that Mr Hurford had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Fraser Government to respond to the present grave difficulties of the Australian motor vehicle industry".

The proposed discussion having received the necessary support—

Mr Hurford addressed the House.

Discussion ensued.

Discussion concluded.

- 10 Suspension of standing orders—Precedence to government business: Mr E. L. Robinson (Minister for Finance), by leave, moved—That so much of the standing orders be suspended as would prevent—
 - (1) government business taking precedence of general business today, and
 - (2) the business listed for general business Thursday No. 12 taking precedence on the Notice Paper on the next general business Thursday.

Ouestion—put and passed.

11 AGENT ORANGE AND VIETNAM VETERANS—MINISTERIAL STATEMENT: Mr Adermann (Minister for Veterans' Affairs), by leave, made a ministerial statement informing the House of the Government's attitude to claims that contact with Agent Orange and other herbicides has adversely affected the health of Vietnam veterans and their children.

Dr Klugman, by leave, also made a statement in connection with the matter.

Mr Holding asked leave to make a statement.

Objection being raised, leave not granted.

- 12 AFGHANISTAN—INVASION BY SOVIET UNION: The order of the day having been read for the resumption of the debate on the motion of Mr Viner (Leader of the House)—
 That this House—
 - condemns the invasion of Afghanistan by the Soviet Union as a gross violation
 of the United Nations Charter and of Afghanistan's non-aligned status; as
 involving acts of aggression and tyranny; as having a critically destabilizing
 effect on the region; and as potentially the gravest threat to international peace
 and security since 1945;
 - (2) notes that a significant majority of world opinion, including Islamic opinion, has viewed the invasion with grave concern—as expressed in resolutions of the United Nations General Assembly on 14 January 1980 and at the Islamic Conference of Foreign Ministers on 29 January 1980;
 - (3) calls for the immediate unconditional and total withdrawal of Soviet troops from Afghanistan in order to enable that country to regain its sovereignty, territorial integrity, political independence and non-aligned status; and to permit its people to determine their own form of government free from external intervention, oppression, coercion or other constraint;
 - (4) with a view to the furtherance of the aforementioned objectives, urges all independent-minded nations to take action separately or in concert to register with the Government and people of the Soviet Union, their abhorrence of the Soviet invasion of Afghanistan, and
 - (5) urges the provision of humanitarian relief assistance to alleviate the hardships of the Afghan refugees in co-ordination with the United Nations High Commissioner for Refugees, and calls for the attainment of conditions necessary to permit the voluntary return to their homes of the Afghan refugees—And on the amendment moved thereto by Mr Hurford, viz.—That all words after "region" be omitted with a view to substituting the following:
 - "(2) notes that a significant majority of world opinion, including Islamic opinion, has viewed the invasion with grave concern—as expressed in resolutions of the United Nations General Assembly on 14 January 1980 and at the Islamic Conference of Foreign Ministers on 29 January 1980;
 - (3) calls for the immediate unconditional and total withdrawal of Soviet troops from Afghanistan in order to enable that country to regain its sovereignty, territorial integrity, political independence and non-aligned status; and to permit its people to determine their own form of government free from external intervention, oppression, coercion or other constraint;
 - (4) with a view to the furtherance of the aforementioned objectives, urges all independent-mined nations to take action separately or in concert to register with the Government and people of the Soviet Union, their abhorrence of the Soviet invasion of Afghanistan;
 - (5) urges the provision of humanitarian relief assistance to alleviate the hardships of the Afghan refugees in co-ordination with the United Nations High Commissioner for Refugees, and calls for the attainment of conditions necessary to permit the voluntary return to their homes of the Afghan refugees;
 - (6) views with extreme concern the possibility that strategic arms limitation may be abandoned and an uncontrolled arms race resumed;
 - (7) urges the Government to recognise the serious problems which exist in Australia's own region and which have a direct effect upon Australia and its future;
 - (8) calls on the Government to take a diplomatic initiative directed at convening an international conference which would have the objective of demilitarising Kampuchea and allowing the people of that country to determine their own future, and
 - (9) condemns the double standard applied by the Prime Minister in sanctions against the Soviet Union by harassing Australian athletes while permitting continued trade."—

Debate resumed.

Debate adjourned (Mr McLean), and the resumption of the debate made an order of the day for a later hour this day.

- 14 LOAN (WAR SERVICE LAND SETTLEMENT) BILL 1980: Mr Howard (Treasurer), pursuant to notice, presented a Bill for an Act to authorize the raising and expending of a sum not exceeding \$3,000,000 for a defence purpose, namely, financial assistance to South Australia and Western Australia in connection with war service land settlement. Bill read a first time.

Mr Howard moved—That the Bill be now read a second time.

Debate adjourned (Mr Scholes), and the resumption of the debate made an order of the day for the next sitting.

15 Local Government (Personal Income Tax Sharing) Amendment Bill 1980: Mr Howard (Treasurer), pursuant to notice, presented a Bill for an Act to amend the Local Government (Personal Income Tax Sharing) Act 1976.

Bill read a first time.

Mr Howard moved—That the Bill be now read a second time.

Debate adjourned (Mr Scholes), and the resumption of the debate made an order of the day for the next sitting.

16 PAY-ROLL TAX (TERRITORIES) ASSESSMENT AMENDMENT BILL 1980: Mr Howard (Treasurer) presented a Bill for an Act to amend the Pay-roll Tax (Territories) Assessment Act 1971. Bill read a first time.

Mr Howard moved—That the Bill be now read a second time.

Debate adjourned (Mr Scholes), and the resumption of the debate made an order of the day for the next sitting.
