1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.

2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:

Mr Armitage, Dr Cass, Dr Everingham, Mr Holding, Mr Innes and Mr Young—from certain citizens praying that positive policies be adopted to reduce unemployment and that certain social security benefits be granted.

Dr Blewett and Mr Burns—from certain citizens praying that the National Women's Advisory Council and its recommendations be supported.

Dr Blewett and Mr Haslem—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.

Mr Chapman and Mr Humphreys—from certain citizens praying that tax laws be reformed to allow joint incomes to be equally divided, for taxation purposes, between husband and wife.

Mr Carlton—from certain residents of New South Wales praying that the 1980 level of education expenditure to Government schools be restored and increased in real terms.

Dr Edwards—from certain citizens praying that sillage charges be an allowable tax deduction.

Mr Garland—from certain citizens praying for the prohibition of pornographic material involving children.

Mr Hodges—from certain citizens praying that taxation laws be amended to increase incentives to persons providing for their own retirement benefits.

Mr Humphreys—from certain citizens praying that taxation laws be amended to achieve effective parity of treatment between the self-employed and employees in the matter of superannuation.

Mr Humphreys—from certain citizens praying that legislation be introduced to require labelling of perfumes, cosmetics and toilet preparations to indicate any use of animal ingredients during manufacture.

Mr Humphreys—from certain citizens praying that Aboriginal land rights in the States be recognised in a manner similar to their recognition in the Northern Territory and that certain other action be taken in connection with Aboriginal and Torres Strait Islander affairs in Queensland.

Mr Humphreys—from certain citizens praying for the prohibition of oil exploration within the Great Barrier Reef region and that the entire region be declared a Marine Park.

Mr Humphreys—from certain electors praying that the Government desist from setting prescriptive guidelines for the Australian Schools Commission and allow it to operate as a national educative advisory body.

Mr Katter—from certain citizens praying that the proposed television transmitter for Greenvale, Qld, have sufficient capacity to provide reception within a 160 kilometre radius of Greenvale.

Mr Young—from certain citizens praying that subsidies to pre-schools be increased to provide adequate pre-school services in South Australia.

Mr Young—from certain residents of the city of Port Adelaide, S.A., praying that the proposal to alter existing railway freight handling arrangements at Port Adelaide Dock Station not be proceeded with.

SCHEDULE OF THE AMENDMENT MADE BY THE SENATE

Page 2, clause 6, proposed section 60, at end of proposed section, add the following new sub-section:

“(2) Sections 48 (other than paragraphs (1) (a) and (b) and sub-section (2)), 49 and 50 of the *Acts Interpretation Act 1901* apply in relation to declarations under sub-section (1) as if, in those sections, references to regulations were references to declarations.”

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE

No. 1—Page 1, clause 3, sub-clause (1), lines 7 to 9, leave out the sub-clause, insert the following sub-clause:

“(1) The Pipeline Authority shall construct a pipeline from Young to Cootamundra and Wagga Wagga in the State of New South Wales consisting of a 324 millimetre diameter pipeline on the route described in Schedule 1 and an 89 millimetre diameter pipeline on the route described in Schedule 2.”

No. 2—Page 1, clause 3, sub-clause (2), line 11, leave out “route described in the Schedule”, insert “routes described in the Schedules”.

No. 3—Page 2, clause 4, line 4, leave out “\$17,500,000”, insert “\$17,600,000”.
