## HOUSE OF REPRESENTATIVES VOTES AND PROCEEDINGS

## No. 166

TUESDAY, 22 APRIL 1980

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Dobie, Mr Fisher, Mr C. K. Jones, Mr MacKenzie, Mr L. B. McLeay, Mr Morris and Mr Street—from certain citizens praying that pensions and benefits be increased and adjusted quarterly and that greater taxation relief be given to pensioners and others on low incomes.
  - Mr Dawkins, Mr Holding, Mr Innes, Mr James, Mr Kerin and Mr Willis—from certain sports men and women and others praying that the participation of a full Australian contingent at the Moscow Olympic Games be ensured.
  - Mr Holding, Mr James and Mr Kerin—from certain citizens praying that a treaty be negotiated between the Aboriginal people of Australia and the Commonwealth.
  - Mr James and Mr Kerin—from certain citizens praying that positive policies be adopted to reduce unemployment and that certain social security benefits be granted.
  - Mr Anthony—from certain citizens praying that the use of 24D and 245T be banned in the Lismore district, N.S.W., until the findings of the Commonwealth Government inquiry into these herbicides are released.
  - Mr Bowen—from certain citizens praying that tax concessions be allowed to approved voluntary overseas aid organisations.
  - Mr J. J. Brown—from certain citizens praying that steps be taken to explore techniques which would replace the use of living animals for scientific investigation.
  - Mr Burns—from certain citizens praying that the National Women's Advisory Council be abolished.
  - Mr D. M. Cameron—from certain citizens praying that steps be taken to reduce the excise duty on Australian rum.
  - Mr Dawkins—from certain citizens praying that eligibility for service pensions be extended to include merchant seamen.

10 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—KIMBERLEY ABORIGINES: Mr Speaker informed the House that Mr West, Mr N. A. Brown and Mr Hodgman had each proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr West, namely, "The urgent need for the use of Commonwealth powers to prevent deteriorating relations between the Kimberley Aborigines and mining companies and the Western Australian Government". The proposed discussion having received the necessary support—

  - (a) transmitting to the House of Representatives particulars of proposed expenditure from the Consolidated Revenue Fund for the service of the year ending on 30 June 1981, for which interim provision is necessary and recommending an appropriation of the Consolidated Revenue Fund accordingly; and
  - (b) recommending to the House of Representatives an appropriation of the Consolidated Revenue Fund for the service of the year ending on 30 June 1981, for the payment of such increases in salaries and wages and payments in the nature of salary, for which provision is made in the attached particulars of proposed expenditure as have become payable or become payable, or have commenced or commence to be paid, during that year in accordance with any law, or in accordance with an award, order or determination made under a law.
  - Mr E. L. Robinson (Minister for Finance) presented a Bill for an Act to make interim provision for the appropriation of moneys out of the Consolidated Revenue Fund for the service of the year ending on 30 June 1981.

Bill read a first time.

Mr E. L. Robinson moved-That the Bill be now read a second time.

Debate adjourned (Mr Hurford), and the resumption of the debate made an order of the day for the next sitting.

12 MESSAGE FROM THE GOVERNOR-GENERAL, CERTAIN PROPOSED EXPENDITURE 1980-81— INTERIM PROVISION—SUPPLY BILL (No. 2) 1980-81: Message No. 254, dated 22 April 1980, from His Excellency the Governor-General was announced transmitting to the House of Representatives particulars of certain proposed expenditure from the Consolidated Revenue Fund in respect of the year ending on 30 June 1981, for which interim provision is necessary and recommending an appropriation of the Consolidated Revenue Fund accordingly.

Mr E. L. Robinson (Minister for Finance) presented a Bill for an Act to make interim provision for the appropriation of moneys out of the Consolidated Revenue Fund for certain expenditure in respect of the year ending on 30 June 1981.

Bill read a first time.

Mr E. L. Robinson moved-That the Bill be now read a second time.

Debate adjourned (Mr Hurford), and the resumption of the debate made an order of the day for the next sitting.

- 13 SUSPENSION OF STANDING ORDERS-GRIEVANCE DEBATE: Mr E. L. Robinson (Minister for Finance), for Mr Viner (Leader of the House), pursuant to notice, moved-
  - (1) That so much of the standing orders be suspended as would prevent the first order of the day, government business, on Wednesday, 23 April, being "Grievance" debate.

- 17 AUSTRALIAN FEDERAL POLICE AMENDMENT BILL 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
  - Debate resumed by Dr Klugman who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "as the present arrangements for the policing of major drug trafficking legislation are unsatisfactory and proposed arrangements for the transfer to the Australian Federal Police of former officers of the Narcotics Bureau will produce anomalies and unfairness, the bill be withdrawn and re-drafted to provide for—
    - the creation of a further major component of the Australian Federal Police to be responsible for the policing of Federal and State drug trafficking legislation, such component to be accountable to the Australian Federal Police Commissioner, and through him to the Minister and the Parliament;
    - (2) the proposed component to comprise A.F.P. officers, together with a significant number of experienced officers seconded from State Police forces, such State officers to continue to operate as far as possible in their home States, and not to be prejudiced in their career advancement by accepting such secondment, and
    - (3) an arrangement whereby former members of the Narcotics Bureau who seek transfer to the Australian Federal Police, and who are considered qualified in this respect by the Commissioner, may be appointed as officers or noncommissioned officers of the proposed new narcotics component".

Adjournment negatived: It being 10.30 p.m.—The question was proposed—That the House do now adjourn.

Mr J. E. McLeay (Minister for Administrative Services) requiring the question to be put forthwith without debate—

Question—put and negatived.

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put.
