 - Mr Holding and Mr James—from certain sports men and women and others praying that the participation of a full Australian contingent at the Moscow Olympic Games be ensured.

 - Mr J. L. McMahon—from certain citizens praying that all Commonwealth controlled land in Mort Bay, Balmain, N.S.W. be given to the people of New South Wales for use as an extension to the Sydney Harbour National Park and that it not be used as a site for a defence base.
