(1) a rate of economic growth per capita less than half the average rate for all O.E.C.D. countries;

(2) a substantial increase in the level of unemployment;

(3) an interest rate regime which has increased substantially this year and will clearly go on increasing:

(4) a rate of inflation which is substantially higher than at the time of the last election and which is steadily increasing;

(5) taxation rates which are the highest in our history;

(6) a decline in the living standards of the great majority of the Australian people, with the decline being most severe for those on the lowest incomes, and

(7) intensified social division and conflict by inequitably redistributing income and wealth.

and calls for the adoption of an alternative strategy to revive economic activity and reduce unemployment, inflation and inequity as advocated by the Opposition".

Debate continued.

Debate adjourned (Mr Cotter), and the resumption of the debate made an order of the day for the next sitting.
