- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Baume, Mr Carlton, Mr Haslem, Mr B. O. Jones, Mr MacKenzie, Mr Nixon and Mr Shipton—from certain citizens praying that funding of the Preston Institute of Technology Chiropractic Program be no longer delayed.
 - Mr Johnston, Mr Killen and Mr Martyr-from certain citizens praying that the National Women's Advisory Council be abolished.
 - Mr Baume and Mr Lucock—from certain citizens praying that steps be taken to compensate the victims of the bomb disaster at the Hilton Hotel, Sydney, N.S.W.
 - Mr Bowen and Mr MacKenzie—from certain residents of New South Wales praying that the allocation of funds for government school programs be restored and substantially increased.
 - Mr N. A. Brown and Mr Neil-from certain citizens praying that pensions and benefits be increased and adjusted quarterly and that greater taxation relief be given to pensioners and others on low incomes.
 - Mr Nixon and Mr Sainsbury—from certain citizens praying that any proposal to legislate for the establishment of plant breeders' rights in Australia be rejected.
 - Mr Baume—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.

Brown—from certain citizens praying that the Government fulfil its stated policy of self-determination and self-management for Aboriginals and use the powers conferred on it by the 1967 referendum to intervene on behalf of the Aboriginal people in any conflict with any State or Territory Government.

 - Mr Ellicott—from certain citizens praying that the National Women's Advisory Council be maintained and Federal Government support for its activities be increased.
 - Mr Ellicott—from certain citizens praying that steps be taken to allow child-care expenses as a deductible item from taxpayers' assessable income.
 - Mr Johnston—from certain citizens praying that carcass trade be promoted and that exports of live animals for slaughter be banned.
 - Mr Johnston—from certain citizens praying that a Lands Commissioner be appointed for Queensland.
 - Mr MacKenzie—from certain citizens praying that Commonwealth road funding be increased for the 1980-83 triennium, active Commonwealth financial interest in the funding of all roads be maintained, and a proportion of all road funds be directed towards local government.

11 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—ECONOMIC SITUATION: Mr Speaker informed the House that both Mr Willis and Mr Cairns had proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr Willis, namely, "The threat of an imminent credit squeeze and steeply rising interest rates stemming from the failure of Government economic management".

12 AIR NAVIGATION (CHARGES) AMENDMENT BILL 1980: Mr Hunt (Minister for Transport), pursuant to notice, presented a Bill for an Act to amend the *Air Navigation (Charges) Act* 1952, and for related purposes.

Bill read a first time.

Mr Hunt moved—That the Bill be now read a second time.

Debate adjourned (Dr Klugman), and the resumption of the debate made an order of the day for the next sitting.

- 13 HANGAR COMPLEX, HMAS Albatross, NOWRA, N.S.W.—APPROVAL OF WORK: Mr Groom (Minister for Housing and Construction), pursuant to notice, moved—That, in accordance with the provisions of the Public Works Committee Act 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the Committee has duly reported to Parliament: Construction of a new hangar complex at HMAS Albatross, Nowra, N.S.W.
 - Debate ensued.

Question—put and passed.

14 AIRCRAFT MAINTENANCE COMPLEX AND ACCESS PAVEMENTS, R.A.A.F. BASE, DARWIN, N.T.—APPROVAL OF WORK: Mr Groom (Minister for Housing and Construction), pursuant to notice, moved—That, in accordance with the provisions of the *Public Works Committee Act* 1969, it is expedient to carry out the following proposed work which was referred to the Parliamentary Standing Committee on Public Works and on which the Committee has duly reported to Parliament: Construction of an aircraft maintenance complex and access pavements at R.A.A.F. Base, Darwin, N.T. Debate ensued.

Question—put and passed.

- 15 SOCIAL SERVICES AMENDMENT BILL 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Dr Klugman who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and re-drafted to provide for—
 - increases in the allowances for children of pensioners and beneficiaries and double orphans' pension to compensate for increases in the Consumer Price Index since they were last increased;

- (2) increases in the mothers'/guardians' allowance to compensate for inflation since it was last increased;
- (3) removal of the discrimination against unemployment beneficiaries in the Social Services Act, and
- (4) increases in family allowance payments to low income families to compensate them for their falling standard of living".

Debate continued.

Question—That the words proposed to be omitted stand part of the question—put. The House divided (the Deputy Speaker, Mr Millar, in the Chair)—

On the motion of Mr Hunt (Minister representing the Minister for Social Security), the following amendment was made, after debate: Clause 22, page 9, omit subclause (3), substitute the following sub-clause:

"(3) In so far as an amendment made by this Act affects instalments of unemployment or sickness benefit, then-

- (a) where the amendment is a prescribed amendment—the amendment applies in relation to every instalment of benefit that falls due on or after the day on which this Act receives the Royal Assent; or
- (b) in any other case—the amendment applies in relation to every instalment of benefit that falls due on or after 1 November 1980.".

Bill, as amended, agreed to.

Bill to be reported with an amendment.

The House resumed; Mr Drummond reported accordingly.

On the motion of Mr Hunt, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

- 16 DEFENCE SERVICE HOMES AMENDMENT BILL (No. 2) 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Mr Uren who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and re-drafted to provide for a more realistic maximum loan limit in the light of house and land prices in the capital cities".
 - Debate continued.
 - Amendment negatived.
 - Question—That the Bill be now read a second time—put and passed—Bill read a second time.
 - Leave granted for third reading to be moved forthwith.
 - On the motion of Mr Adermann (Minister for Veterans' Affairs), the Bill was read a third time.
- 17 REPATRIATION ACTS AMENDMENT BILL 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Question—put and passed—Bill read a second time.
 - Message from the Governor-General: Message No. 293, dated 27 August 1980, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.
 - Leave granted for third reading to be moved forthwith.
 - On the motion of Mr Adermann (Minister for Veterans' Affairs), the Bill was read a third time.
- 18 NATIONAL HEALTH AMENDMENT BILL (No. 2) 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—
 - Debate resumed by Dr Blewett who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not opposing the Bill, the House regrets the Government's failure to extend pensioner health benefit provisions to unemployed beneficiaries, the only major category of social service beneficiaries excluded from pensioner health benefit provisions".
 - Debate continued.
 - Mr Kerin addressing the House-
 - Adjournment negatived: It being 10.30 p.m.—The question was proposed—That the House do now adjourn.
 - Mr MacKellar (Minister for Health) requiring the question to be put forthwith without debate—

Question—put and negatived.

Mr Kerin continued his speech.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

New clause—

On the motion of Mr MacKellar (Minister for Health), the following new clause was inserted in the Bill, after debate:

Panels for appointments to Committees

"4A. (1) Section 50 of the Principal Act is amended by omitting paragraph (d) of sub-section (1) and substituting the following paragraph:

(d) the Royal Australian College of Obstetricians and Gynaecologists; and'.

"(2) Where there was, immediately before the commencement of this section, a member of a Committee who was appointed from a panel nominated by the body referred to in paragraph 50 (1) (d) of the Principal Act, then, for the purposes of the operation of sections 53 and 56 of the Principal Act as amended by this Act, the member shall be deemed to have been appointed from a panel nominated by the body referred to in paragraph 50 (1) (d) of the Principal Act as amended by this Act, the Member shall be deemed to have been appointed from a panel nominated by the body referred to in paragraph 50 (1) (d) of the Principal Act as amended by this Act."
