- 1 The House met, at 10.30 a.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mr Hunt and Mr Lusher—from certain citizens praying that the Travelling Post Office service be retained in New South Wales.
 - Dr Cass—from certain citizens praying for the prohibition of oil exploration within the Great Barrier Reef region and that the entire region be declared a Marine Park.
 - Mr Connolly—from certain citizens praying that section 79 (1) of the Family Law Act be amended to allow Family Courts to be made open to the public and to permit publication of the details of their proceedings provided that names of parties and other identifying information is prohibited from disclosure.
 - Mr Fry—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.
 - Mr Hunt—from certain citizens praying that the National Women's Advisory Council be abolished.
 - Mr Innes—from certain citizens praying that work be found for the unemployed in Flemington, Vic., especially school leavers, and that social security and welfare payments be adjusted to a guaranteed minimum income above the poverty line.
 - Mrs Kelly—from certain citizens praying that goats milk formulae be restored to the Pharmaceutical Benefits Scheme.
 - Mr Uren—from certain citizens praying that any proposal to legislate for the establishment of plant breeders' rights in Australia be rejected.
 - Mr Uren—from certain citizens praying that a treaty be negotiated between the Aboriginal people of Australia and the Commonwealth.
 - Mr Uren—from certain citizens praying that immediate steps be taken to end commercial whaling.
 - Mr Uren—from certain citizens praying that the importation and use of the chemical sprays 2,4-D and 2,4,5-T be banned until all doubts about the harmful effects of their use are resolved by scientific investigation.
 - Mr Young—from certain citizens praying that funding of the Preston Institute of Technology Chiropractic Program be no longer delayed.
 - Mr Young—from certain citizens praying that steps be taken to compensate the victims of the bomb disaster at the Hilton Hotel, Sydney, N.S.W. Petitions received.
- 3 QUESTIONS: Questions without notice were asked.

4 Privilege: Mr Holding raised as a matter of privilege the withholding, by the Parliamentary Library, on legal advice, from circulation to Members of a copy of the book *Documents on Australian Defence and Foreign Policy*, 1968-1975 pending a decision in a relevant matter before the High Court of Australia. Mr Holding stated that the action tended to impair Members' independence in the future performance of their duties.

Mr Sinclair (Leader of the House), Mr Scholes and Mr Bowen (Deputy Leader of the Opposition) addressed themselves to the matter of privilege.

Mr Speaker stated that, in his opinion, the matter did not constitute a *prima facie* case of breach of privilege as would enable it to take precedence over other business.

5 SUSPENSION OF STANDING ORDERS MOVED: Mr Holding moved—That so much of the standing orders be suspended as would prevent the Member for Melbourne Ports from referring to the Committee of Privileges the action of the withholding of information possessed by the Parliamentary Library from Members of the House of Representatives.

Closure of Member: Mr Sinclair (Leader of the House) moved—That the honourable Member be not further heard.

9 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—QUEENSLAND—OWNERSHIP OF PROPERTY AND RESOURCES: Mr Deputy Speaker informed the House that Mr Keating had proposed that a definite matter of public importance be submitted to the House for discussion, namely, "The failure of the Fraser Government to check the alienation of Australian ownership and control of property and resources in Queensland by the policies of the Queensland Government".

The proposed discussion having received the necessary support—

10 JUDICIAL APPOINTMENT (WESTERN SAMOA) BILL 1980: Mr Viner (Minister representing the Attorney-General), pursuant to notice, presented a Bill for an Act relating to the appointment of the Honourable Robert James Baldwin St John as Chief Justice of the Supreme Court of Western Samoa.

Bill read a first time.

Mr Viner moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

11 REMUNERATION AND ALLOWANCES AMENDMENT BILL 1980: Mr Viner (Minister Assisting the Prime Minister), pursuant to notice, presented a Bill for an Act to amend the Remuneration and Allowances Act 1973.

Bill read a first time.

Mr Viner moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

12 Christmas Island Amendment Bill 1980: Mr Ellicott (Minister for Home Affairs and Environment), pursuant to notice, presented a Bill for an Act to amend the *Christmas Island Act* 1958.

Bill read a first time.

Mr Ellicott moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

13 MIGRATION AMENDMENT BILL (No. 2) 1980: Mr Macphee (Minister for Immigration and Ethnic Affairs), pursuant to notice, presented a Bill for an Act to amend the *Migration Act* 1958 and for purposes connected therewith.

Bill read a first time.

Mr Macphee moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

14 IMMIGRATION (UNAUTHORIZED ARRIVALS) AMENDMENT BILL 1980: Mr Macphee (Minister for Immigration and Ethnic Affairs), pursuant to notice, presented a Bill for an Act to extend the application of the *Immigration (Unauthorized Arrivals) Act* 1980 to the Territory of Christmas Island.

Bill read a first time.

Mr Macphee moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

15 MINISTERS OF STATE AMENDMENT BILL 1980: Mr Newman (Minister for Administrative Services), pursuant to notice, presented a Bill for an Act to amend the *Ministers of State Act* 1952.

Bill read a first time.

Mr Newman moved—That the Bill be now read a second time.

Debate adjourned (Mr J. J. Brown), and the resumption of the debate made an order of the day for the next sitting.

- 16 Suspension of standing orders—Sales Tax Bills: Mr Hodgman (Minister for the Capital Territory), for Mr Sinclair (Leader of the House), pursuant to notice, moved—That, in relation to the proceedings on any Sales Tax Bills, so much of the standing orders be suspended as would prevent—
 - (a) the presentation and the first readings of the Bills together;
 - (b) one motion being moved and one question being put in regard to, respectively, the second readings, the committee's report stage, and the third readings, of all the Bills together, and
 - (c) the consideration of all the Bills as a whole together in a committee of the whole. Debate ensued.

Question—put and passed.

17 AGED OR DISABLED PERSONS HOMES AMENDMENT BILL 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Dr Blewett who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and re-drafted to provide an increase in the Personal Care subsidy commensurate with the increase in the cost of living since the subsidy was last increased in 1974".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Message from the Governor-General: Message No. 1, dated 26 November 1980, from His Excellency the Governor-General was announced recommending an appropriation of revenue for the purposes of the Bill.

Leave granted for third reading to be moved forthwith.

On the motion of Mr Hunt (Minister representing the Minister for Social Security), the Bill was read a third time.

18 Homes Savings Grant Amendment Bill 1980: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Uren who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "the Bill be withdrawn and re-drafted to provide for—

(1) assistance according to an income means test instead of the price of the house as at present;

(2) maximum assistance on the basis of need;

(3) equitable distribution of assistance in the context of wide regional variation in

housing prices;

(4) a more effective scheme of assistance to first home buyers which will act to reduce the widening deposit gap and so limit the requirement of home buyers to obtain high-interest rate second mortgage finance and ease the current repayment burdens which impose hardship on a growing number of people paying off home loans, and

(5) the urgent elimination of the present 9 month waiting period for home savings

grant applicants".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed—Bill read a second time.

Leave granted for third reading to be moved forthwith.

On the motion of Mr McVeigh (Minister for Housing and Construction), the Bill was read a third time.
