## TUESDAY, 24 MARCH 1981

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 PETITIONS: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
  - Mr Beazley, Mr N. A. Brown, Mr Bungey and Mr McLean—from certain residents of Western Australia praying that steps be taken to formulate an airline policy providing for greater competition so that prices and service are determined by free market forces.
  - Mr Free, Mr McLeay, Mr J. L. McMahon and Mr Mountford—from certain citizens praying that funding of children's services be restored to at least the real value of funding allocated in the 1975-76 Budget and future allocations be spent in full for the purposes designated.
  - Mr Anthony, Mr Chapman and Mr Fife—from certain citizens praying that the Metric Conversion Act be repealed and the traditional and familiar weights and measures be restored.
  - Mr Jacobi, Mr Nixon and Mr Porter—from certain citizens praying that any proposal to legislate for the establishment of plant variety rights in Australia be rejected.
  - Mr Bungey and Mr Rocher—from certain citizens praying that private and confidential medical records be protected from scrutiny.
  - Mr Hunt and Mrs Kelly—from certain citizens praying that laws be passed to outlaw discrimination in employment and in the provision of unemployment benefits, based upon race, ethnic origin, marital status and sex.
  - Mr Kerin and Mr Robinson—from certain citizens praying that any proposal to legislate for the establishment of plant breeders' rights in Australia be rejected.
  - Mr Free—from certain electors of the Electoral Division of Macquarie praying that Telecom Australia be directed to provide an adequate service to subscribers and users in the 047 telephone zone.
  - Mr Giles—from certain citizens praying that the Human Rights Commission Bill 1979 and the Racial Discrimination Amendment Bill 1979 be returned to the Senate so that all elected Senators are able to be present and vote on the legislation.
  - Mr Holding—from certain citizens praying that the amended work test procedure for determining eligibility for unemployment benefits be repealed.
  - Mr Humphreys—from certain citizens praying that legislation be introduced to require labelling of perfumes, cosmetics and toilet preparations to indicate any use of animal ingredients during manufacture.
  - Mr Humphreys—from certain citizens praying that Service Pensions be extended to all merchant seamen who served in theatres of war.
  - Mr Humphreys—from certain citizens praying that requests for export permits covering mineral sand products from Moreton Island, Qld, be refused.

Mr Jull—from certain citizens praying that the imperial system of weights and measures be restored.

Mr Jull—from certain citizens praying that the National Women's Advisory Council be abolished.

Mr Jull—from certain citizens praying that the sales tax on recorded music be abolished or substantially reduced.

Mrs Kelly—from certain citizens praying that steps be taken to allow child-care expenses as a deductible item from taxpayers' assessable income.

Dr Klugman—from certain citizens praying that local community health centres receive adequate funds to continue and expand their services to the community.

Mr Mildren—from certain residents of Ballarat and district, Vic., praying that the 1981 funding allocation for the Ballarat Community Youth Support Scheme be restored immediately to a level that will permit the maintenance of the project's current staffing level.
