WEDNESDAY, 6 MAY 1981

- 1 The House met, at 2.15 p.m., pursuant to adjournment. Mr Speaker (the Right Honourable Sir Billy Snedden) took the Chair, and read Prayers.
- 2 Petitions: The Clerk announced that the following Members had each lodged petitions for presentation, viz.:
 - Mrs Child, Mr Johnson, Mr C. K. Jones, Mr Keating, Mr McLeay, Mr J. L. McMahon, Mr Milton, Mr Morris and Mr Scott—from certain citizens praying that any proposal to sell Trans Australia Airlines be rejected.
 - Mr Bourchier, Mr Hyde, Mr J. L. McMahon and Mr Scott—from certain citizens praying that the House recognise the importance of the hotel industry and that any proposal to increase the excise on beer be rejected.
 - Mr Beazley and Mr Tambling—from certain citizens praying that steps be taken to allow child-care expenses as a deductible item from taxpayers' assessable income.
 - Dr Cass and Mr Howe—from certain citizens praying that any proposal to deny unemployment benefits to unemployed persons under 18 years of age be unconditionally withdrawn and that certain other action be taken in regard to unemployment benefits and employment policies.
 - Mr Dean and Mr Fraser—from certain citizens praying that private and confidential medical records be protected from scrutiny.
 - Mr J. L. McMahon and Mr Scott—from certain citizens praying that funding of children's services be restored to at least the real value of funding allocated in the 1975-76 Budget and future allocations be spent in full for the purposes designated.
 - Mrs Child—from certain citizens praying that sanitary products for women be brought under the scrutiny of the Australian Drug Evaluation Committee and certain other actions be taken in regard to the possible threat posed to the health of women by toxic shock syndrome.
 - Mr Humphreys—from certain citizens praying that Service Pensions be extended to all merchant seamen who served in theatres of war.
 - Mr Humphreys—from certain citizens praying that legislation be introduced to require labelling of perfumes, cosmetics and toilet preparations to indicate any use of animal ingredients during manufacture.
 - Mr Humphreys—from certain citizens praying that legislation be enacted to require the production of annual statistics on the numbers of live animals involved in research and that the National Health and Medical Research Council be required to develop humane and responsible standards of conduct for research using live animals in laboratories.
 - Mr Humphreys—from certain citizens praying that requests for export permits covering mineral sand products from Moreton Island, Qld, be refused.
 - Mr Johnson—from certain residents of the Northern Territory praying that the offer of Darwin or any other location as a base or depot for American B-52 bombers be withdrawn and any request by the United States Government for the use of bases in Australia be rejected.

- Mr C. K. Jones—from certain citizens praying that the government of the United States of America be urged to cease all military aid to El Salvador and support be given to the freedom of the Salvadorian people against the governing military dictatorship.
- Mrs Kelly—from certain electors of the Electoral Division of Canberra praying for a review of the problems caused by the routing of high speed transit traffic to and from Tuggeranong Valley, A.C.T., through the southern Woden suburbs and that the situation be remedied immediately.
- Mr J. L. McMahon—from certain citizens praying that section 79 (1) of the Family Law Act be amended to allow Family Courts to be made open to the public and to permit publication of the details of their proceedings, provided that the names of parties and other identifying information are prohibited from disclosure.

- 6 DISCUSSION OF MATTER OF PUBLIC IMPORTANCE—COMMONWEALTH FUNDING TO THE STATES: Mr Speaker informed the House that both Mr Willis and Mr Ruddock had proposed that definite matters of public importance be submitted to the House for discussion today. In accordance with the provisions of standing order 107, he had given priority to the matter proposed by Mr Willis, namely, "The severe implications of the Government's action in failing to provide adequate funds to the States".

7 CUSTOMS TARIFF (ANTI-DUMPING) AMENDMENT BILL 1981: Mr Moore (Minister for Business and Consumer Affairs) presented a Bill for an Act to amend the Customs Tariff (Anti-Dumping) Act 1975.

Bill read a first time.

Mr Moore moved-That the Bill be now read a second time.

Debate adjourned (Mr West), and the resumption of the debate made an order of the day for the next sitting.

8 Customs Amendment (Securities) Bill 1981: Mr Moore (Minister for Business and Consumer Affairs) presented a Bill for an Act to amend the *Customs Act* 1901 in relation to securities.

Bill read a first time.

Mr Moore moved—That the Bill be now read a second time.

Debate adjourned (Mr West), and the resumption of the debate made an order of the day for the next sitting.

9 CUSTOMS TARIFF AMENDMENT BILL 1981: Mr Moore (Minister for Business and Consumer Affairs) presented a Bill for an Act to amend the Customs Tariff Act 1966.

Bill read a first time.

Mr Moore moved-That the Bill be now read a second time.

Debate adjourned (Mr West), and the resumption of the debate made an order of the day for the next sitting.

10 INDUSTRIAL RESEARCH AND DEVELOPMENT INCENTIVES AMENDMENT BILL 1981: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr B. O. Jones who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House—

(1) expresses its concern at-

- (a) the low level of Government investment in research and development compared to other technologically advanced nations;
- (b) the failure of the Government to encourage significant private sector investment in research and development;
- (c) the low level of Australian innovation as measured by the number of patents taken out each year by Australian individuals and companies;
- (d) the failure of the Government to stimulate Australian innovation in electronics, biotechnology and other high technology industries, and
- (e) Australia's disadvantageous position in relation to technology transfer;
- (2) condemns the Government for losing national control over significant industries based on high levels of research and development, including motor manufacturing, electronics, the computer industry and petrochemicals, and
- (3) rejects those parts of the report of the Review of Commonwealth Functions (the 'Lynch Committee') which eliminate or downgrade Commonwealth instrumentalities concerned with the collection, dissemination and application of information about high technology in industry, thereby reducing Australia's fightback capacity in high technology areas".

Clause 15-

Page 6, line 25, omit "and".

Page 6, after paragraph (b) insert the following word and paragraph:

"and (c) by adding at the end thereof the following sub-section:

(2) The master of an oversea vessel arriving in Australia or the Cocos Islands shall not, except by reason of stress of weather or for other reasonable cause, cause or permit the vessel to be—

(a) beached in Australia or the Cocos Islands, as the case may be; or

(b) moored, anchored or otherwise secured in waters on the landward side of the low-water mark around the shore of the continent, or an island, forming part of Australia or of an island forming part of the Cocos Islands, as the case may be,

otherwise than at a port.

Penalty: \$5,000 or imprisonment for 2 years.".

Bill, as amended, agreed to.

Bill to be reported with amendments.

On the motion of Mr MacKellar, by leave, the House adopted the report, and, by leave, the Bill was read a third time.

12 CENSUS AND STATISTICS AMENDMENT BILL 1981: The order of the day having been read for the resumption of the debate on the question—That the Bill be now read a second time—

Debate resumed by Mr Willis who moved, as an amendment—That all words after "That" be omitted with a view to substituting the following words: "whilst not declining to give the Bill a second reading, the House is of the opinion that the Bill is deficient in that it fails to give effect to the recommendation of the Australian Law Reform Commission's Report *Privacy and the census* that identified census information should be held in Archives with access forbidden for 75 years, except for strictly limited access for purposes of medical research".
